TMT Members and Alternates,

Beginning today, June 29, the Corps raised the Little Goose Dam forebay operating range to 1 foot above the Minimum Operating Pool (MOP) for the purpose of navigation safety. This operational adjustment was made to maintain the minimum depth at the downstream entrance to the navigation lock at Lower Granite Dam. This operation is discussed in greater detail in the 2018 Fish Operations Plan on page FOP-10 in section 4.6 Navigation Safety. The Corps will provide an update to the TMT on this operation at the next meeting which is scheduled for Wednesday, July 11.
