

MEMORANDUM FOR: FPOM Coordination Team

Subject: FPOM Task Group Participation List (**DRAFT PREDECISIONAL DOCUMENT**)

1. FPOM Task Groups (TG) are intended to investigate and address special topics and issues raised during FPOM monthly meetings. While each Task Group is specific to its subject, there is a need for a Core membership of the same people participating on all TGs. As well, Specific members will volunteer for, or be selected, for individual TGs to which only those Specific members attend, to work the issue with the Core members of that TG. There could be two Core lists, one for each District. Specific membership will vary among TGs, and may be independent of Districts' Core membership. That is, some lower Columbia folks may want to become involved in, e.g. Snake River dam or McNary dam issues, or vice-versa. Specific members from both Districts may wish to address a topic common to one or both Districts' facilities, such as lamprey entrapment behind diffuser gratings. Specific members are only required to participate in one TG, but they may participate in more than one to their choosing.

Below, I have created a list of potential participants for the Core membership. For Specific membership, I did not create any list yet. Core TG members will be pre-selected during an upcoming FPOM meeting (therefore this list may change), and will attend all TG meetings and become involved in investigation and assignments related to the task. Specific members will be selected during the FPOM meeting at which the task was created, according to their prior knowledge and experience, or desire to become a member of the TG, to address the task in question. Specific TG members are required to serve on only one Task Group, or they may chose to participate in more than one if they are or want to become knowledgeable of the topic.
