 - 3.1.1.1. 22 LWG 08 MOC BPA Outage 500 kV line scheduled 14-18 November, No update
 - **3.1.1.2.** 22 LWG 04 MOC T1T2 Gasket Repair T1A scheduled for 28 November, Project is still looking like it will occur this fall. Bettin A month long but the outage will only be 12 hours a day.
 - 3.1.1.3. 22 LGS 08 MOC BPA Outage 500 kV line scheduled 7-11 November, No update
 - **3.1.1.4.** 20 LGS 16 MOC Powerhouse Roof Repair Outage in December to reconnect bus link is moved to January to accommodate another BPA outage, working to reduce the number of outages.
 - **3.1.1.5.** 22 LMN 06 MOC BPA Outage 500 kV line scheduled Oct 31–4 Nov,

3.2.1.Upcoming maintenance/construction/research activities (previously coordinated MOC/MFRs).

- **3.2.1.1.** 21BON001 MOC Navigation Lock 1 (old navlock) Bridge Replacement scheduled for CY 2023. (Trachtenbarg) update Trachtenbarg Will update next month.
- 3.2.1.2. 22BON089 MOC Spillway B-Branch Erosion and Attraction Follow outage, (Derugin), Update Derugin ROV and Hydrosurvey done, will update the MOC, the PDT is being formed. Planning winter maintenance to allow a month and a half of work for end of January and beginning of Feb. Front loading Cascade Island work. Structurally the ladder seems to be ok and should be able to be left on.
 Lorz When will it be fixed? Please let us know if the dates need to be shifted.
- **3.2.1.3.** 19TDA04 MOC East side powerhouse, Update No activity on the crane rails, fixes will be delayed, focusing on fixing the crane itself.
- **3.2.1.4.** 18JDA02 MOC Trash rack replacement Is fabrication completed? Update Fabrication is complete on 1 with 6 additional, scheduled for mid-November delivery, forming dive plan, planning on starting on unit 16. Will update MOC after seeing the dive plan.
- **3.2.1.5.** 20JDA04 MOC STS crane replacement, has design phase been completed? Update no update.
- **3.2.1.6.** 22JDA07 MOC Block Study concluded 17 August, Results being reviewed, Update Working on memo, should be out for review soon.
- **3.2.1.7.** BON ITS end gate. January delivery date. Derugin update should be a month-long outage. An MOC is in progress as well as a teletype. It takes a week to dewater, two weeks for the work to be completed and then a week to bring everything back online.
- Lorz How long to get it done? Do we have 3 automated gates? Derugin Yes.
- Conder Maybe it would make sense to dewater in Jan rather than in March. An outage in Jan would be supported by NOAA. Are PIT tags arrays going to be included? Derugin Still needs to be discussed.
- **3.2.1.8.** Bon ITS PIT Detector Conder If funding could be found, it may be a good time to look at an install. Bettin 1A is the only gate that will be fully out.
- **3.2.2.**TDA AWS debris management, (McDonald) Update No update, FFDRWG has been given an update for the 50% EDR, further updates will be provided when there are only two alternatives remaining.
- **3.2.3.**TDA trunnion pin, Update Cordie -Trunnion pin is not fixed. Going forward with the spillbay 10 fix using gear box and wire from bay 9. Should be fixed in a couple weeks.
- **3.2.4.**TDA N Ladder Rockfall P#449517 \$60k submitted for FY25 budget. Two options for dewatering: 1. shorten the East dewater to add more to North or 2. Overlap the dewatering's, would require FPOM approval.
 - Lorz How long is the timeframe? Cordie It will be out a ways, likely trunnion pin type timeframe.
- **3.2.5.**JDA north pump #4. OOS for the entire year, Funding needed for O&M next summer, Update Project has put together a PMT for it. Working on getting a UFR in the FY25 budget submission
- **3.2.6.** JDA spill bay 10, Still in manual operation, Update Still in manual likely into next spill season.
- **3.2.7.**JDA SFL Temperatures, collected till the end of September, Update Pulled the array in the forebay, will remove hobos in winter dewatering.

Bettin – where will the AFEP meeting be? It will be virtual.




A new application from Lamprey translocation. Most of the permits are with real estate. Receiving applications for next year. Finalizing the guide.

3.6. Fish Count Program update (Peery, Wertheimer).

3.6.1.BON WDFW - Have personal shortages been resolved? – It has been resolved. Wertheimer - Met with 4 peaks, counts have continued to be provided. Having a meeting to review the last year.

3.7. Pinniped update

3.7.1.Bonneville Dam – Wertheimer - Numbers are below the 20-animal threshold, ready to count when above that number. Have been doing a daily point count, there have been 8-12

animals. Agencies who are doing the work can answer on the actions they are taking for removals.

Lorz - What have the numbers been?

Derugin – Some flags may be put on tower island to dissuade use.

3.7.2. Willamette Falls – Van Dike – ODFW pinniped Staff have been surveying pinniped presence in the lower Willamette River since September, and they have not observed any pinniped activity since September. Although there has been a dozen or less animals around the Bonneville Dam traps, the pinniped staff are not currently trapping.

3.8. Lamprey update

- **3.8.1.**BON LPS Derugin Counts are dropping, the LPS have been running well.
- **3.8.2.**TDA Cordie Trappers are done. Lamprey improvements have been proposed.
- **3.8.3.**JDA Grosvenor -Funding has arrived for water supply for the north fish ladder, hopping to start this winter and complete by next spring.

Van Dyke – Did we get funding? Yes.

- **3.8.4.**NWW St. John No updates this time of year, counts are low, and things have wrapped up for the year.
- **3.8.5.**Lamprey Accords Work Group (Macdonald) No additional updates.
- **3.9. BPA update**. Bettin LGS outage may move to January.
- **3.10.** NWP/NWW Critical Fish Passage O&M needs. Available on the FPOM website, send comments to Mackey by the first of December.

3.11. Avian updates (10:30)

- **3.11.1.**NWW St John Counts are winding down for the season. 25 to 50 gulls and cormorants at LGN 0 to 20 gulls and cormorants at LGS 28 to 101 gulls and 38 to 50 cormorants at LMN. Birds seem to be going away for the season.
- **3.11.2.**JDA Grosvenor About 100 gulls at the project along Nav Lock, Preachers Island has a few pelicans. There are 11 avian lines down currently, working on getting them repaired.
- **3.11.3.**TDA Cordie Very few gulls currently. About 40 cormorants around the project and a few at the east fish ladder exit.
- **3.11.4.**BON Derugin Nothing new to report.
- **3.11.5.**Estuary Tidwell Working on annual reports. Responding to requests from the CFITFC Avian Task group for ESI next year.

Lorz - Have the ESI tags been uploaded?

Tidwell - Not yet we are working on it.

3.11.6.NEPA hazing task group – Schmidt – We have shared a schedule to be on track for a draft in December. Working on EA revisions right now from the draft. Starting cooperator agency meetings, could use help with facilitation weekly meetings. Have not received any response from cooperators AFIS and USFWS are the agencies.

Lorz – There are concerns about pelicans could lengthen the timeline.

Schmidt – Adding hazing pelicans should not add to the timeline, lethal take could. MacDowell – Add hazing but wait on lethal for pelicans. Adding lethal should be a separate EA process. Hazing falls under a more general operation than looking at a very specific question like AWP diet.

Morrill – Diet studies of AWP should be looked at before lethal take.

Macdonald – Are we going to be implementing lethal reinforcement at TDA in 2023? Will data be consolidated by December?

Grosvenor – 2022 data is summarized and can be sent. Cordie – ours can be sent as well. Schmidt – We rely on AFIS to do the implementation, key personnel have left, there is a low chance they will be able to support in 2023. Other avenues have been explored for contracting but have not found another route yet, still getting NEPA and permits. There may be a year delay. The delay is caused by not having personal on the ground.

Mackey – Putting together the work plan for hazing and lethal take, moving forward with the anticipation that we can do lethal this spring. Our NEPA will be in place.

This forum does not deal with wildlife crime, investigations can take a long time and can involve undercover investigations, this may not be something that should be included in FPOM. It should go to enforcement first.

Cordie – has anybody heard of these issues and has anything been done about it? David Ladouceur is the one who filed the incident reporter. This is an area open to the public.

Derugin – there spots in BON pool that have had fish dumped as well. Reaching out to local game wardens can be helpful, if there is an issue with die-offs etc. then it should be sent to the group.

Conder – Its relevant with the TAC group and should go through them.

Morrill – Will reach out to regional enforcement. Hotlines can be used to contact enforcement.

Porter – Is CRIFC getting this information? TAC is now aware of it. Working on how to keep information available but not to jeopardize an investigation.

Mackey – We will work with law enforcement.
