MEMORANDUM FOR THE RECORD

SUBJECT: 14BON63 MFR – Bonneville Adult Fish Facility (AFF) Operation.

Record numbers of fall Chinook are currently passing through Bonneville Dam with the majority passing via the Washington ladder. Special split flow operations were implemented on 4 September to try to balance flow between the two powerhouses at Bonneville and attract more fish towards the Bradford (Oregon) ladder. Even so, the Washington shore ladder has been passing more fish; on 6 September over 36,000 adult salmonids passed the Washington count station, and on 7 September over 52,000 passed. These conditions have caused obvious fish stacking in the ladder.

Current language in the Fish Passage Plan (FPP), Appendix G, states that when adult salmonids counts at the Washington shore count station exceed 18,000 fish, researchers in the AFF may leave all four picket leads lowered for an hour before raising two picket leads for half an hour. Due to the sheer volume of fish passing and their observations of fish amassing below the picket leads during operation of the AFF, BON Project Fisheries has determined that no picket lead operation should be implemented to avoid delaying fish. Project Fisheries in exercising the authority, provided under the 2014 FPP Appendix G, section 1.3.12, to raise picket leads when necessitated by fish densities and/or ladder conditions. Until fish numbers in the Washington Shore fishway decrease, no picket leads will be lowered at the AFF.
