Description of the problem – Due to the frequent operation of the B2CC this spring, the kelt trigger is not likely to be met, even after the B2CC is expected to close on 20 March.

An email was sent to FPOM on 18 March -

Subject: FPOM: Official Coordination - leaving the B2CC open after Sunday

A MOC/MFR will be coming, however, in the meantime, I need thoughts from FPOM on keeping the B2CC open after Sunday to facilitate kelt passage. There have been different conversations occurring at different levels and we need to bring it together in a FPOM coordination.

We recommend opening during daylight hours every day. BON needs the B2CC closed to accommodate some avian line work next week.

I know it's Friday so let's plan on a Monday afternoon call, if we need it.

Type of outage required – The B2CC would remain open 24 hours a day/seven days a week, continuing from 20 March 2022.

Impact on facility operation – There would be no unusual impact on the facility. There will need to be a coordinated closure to allow BON Project to reinstall avian lines. This should take one day or less.

Dates of impacts/repairs – The B2CC has been open, continuously, since 16 March and will continue to remain open, aside from coordinated closures, until the end of spill season (31 August).

Length of time for repairs - NA for this coordination

Analysis of potential impacts to fish – No unusual impacts anticipated since the B2CC would normally be open around this time if the kelt trigger were to be in place.

Summary statement - expected impacts on:

There are no negative impacts anticipated with this operation. This coordination allows for the B2CC to remain open through 31 August in-lieu of meeting the kelt trigger.

BPA understands the request from NOAA during today's 5-agency Deputies meeting and the new information surrounding atypical operations at Bonneville Dam that have precluded data from being collected to meet the kelt trigger, which is often met by March 20. Based on Colotelo et al. studies on kelt passage during late March and April, BPA leadership supports the continued operation of the B2CC for kelt passage beyond March 20 at 13:00 and through the start of spring spill operations, when it does not interfere with the Corps maintenance needs.

BPA leadership is aware of and supports the subgroup that has formed to work through the regional forum process and address potential future modifications that could be applied to the current kelt biological trigger that is tied with the operation of the B2CC.

I will follow-up with our TMT members, Tony Norris and Scott Bettin as soon as feasible today. I have cc'd them here to help with communications.

B2CC will remain open 24/7 until 31 August. BON Project needs to coordinate a closure of B2CC and Bay 18 to hang the avian lines.

FPOM agrees with closing the B2CC at 0800 until the end of the day to allow for the avian line work. Conder noted that NOAA doesn't object but would prefer to have this type of work completed prior to mid-March to avoid impacting the B2CC operation.

Derugin explained that the work was scheduled sooner, but to overlap with USGS work, they delayed the work a bit.

Bettin asked Conder about the purpose of this operation. Conder explained NOAA felt the trigger was compromised due to the other previous B2CC operations.

Derugin said there is a hydro-survey crew coming out to survey the PH2 forebay. BON and the hydro-survey crew will work to coordinate activities for the same day to reduce the need for closures.

Wright will draft the teletype to allow for the closure of the B2CC from 0800 until the work is completed or 1700, whichever occurs first, on 22 March 2022.

1. EFFECTIVE IMMEDIATELY AND CONTINUING UNTIL FURTHER NOTICE, OPERATE THE BONNEVILLE DAM POWERHOUSE TWO CORNER COLLECTOR (B2CC) ALL HOURS, EXCEPT AS NOTED BELOW:

* 1.B) CLOSE THE B2CC ON TUESDAY, MARCH 22, AT 0800cHOURS FOR A BOAT TO ACCESS THE BRZ AND REPAIR AVIAN LINES. ESTIMATED DURATION IS APPROXIMATELY 9 HOURS. THE START TIME MAY BE ADJUSTED LATER IF REQUESTED BY THE BOAT OPERATOR. UPON NOTIFICATION THAT THE BOAT HAS EXITED THE BRZ, RE-OPEN THE B2CC AND RESUME OPERATING THE B2CC 24 HOURS/DAY. THE POINT-OF-CONTACT FOR THIS WORK IS SCOTT MAC KINNON, 541-374-3858.

2. THIS OPERATION SUPERSEDES CRITERIA IN THE 2022 FISH PASSAGE PLAN (FPP) SECTION 2.3.2.5.V ON PAGE BON-20. THE ABILITY TO COUNT KELTS AT THE BONNEVILLE DAM SMOLT MONITORING FACILITY (SMF) HAS BEEN IMPACTED BY RECENT OPERATIONS OF THE B2CC AND SPILLWAY DURING INVOLUNTARY SPILL, AS WELL AS THE SUSPENSION OF SMF SAMPLING FROM MARCH 11 THROUGH MARCH 20 DUE TO MULTIPLE EMERGENCY RELEASES FROM THE SPRING CREEK FISH HATCHERY. THESE FACTORS REDUCED THE ABILITY TO COUNT KELT AT THE SMF. THUS, THE KELT TRIGGER CRITERIA IN THE FPP IS NOT APPLICABLE THIS YEAR.
