OFFICIAL COORDINATION REQUEST FOR NON-ROUTINE OPERATIONS AND MAINTENANCE

COORDINATION TITLE- 13TDA08 fish unit PUD outage COORDINATION DATE- 11/6/13 PROJECT- The Dalles Dam RESPONSE DATE- 11/08/13

Description of the problem- In preparation for this year fishway dewatering below tailwater, bulkhead sills must checked/cleared of debris. Primary focus is each side of the spillway which often pushes debris into these areas. Any small gravel sized debris under the seal can result in extensive leakage and delays in the dewatering and maintenance schedule. Therefore, project is requesting and inspection of the north and south entrance bulkhead sills via ROV and diver if necessary for any large debris removal. The outage date was determined by the very full work schedule of the District ROV staff. It needs to be completed prior to the fishway outage dates.

Type of outage required- PUD turbine out of service on 11/12/13 from ~0900-1100. Fish unit F1 and F2 out of service ~1200-1400. Both fishways will not be out of service simultaneously.

Impact on facility operation- Attraction water will be off for maximum 2 hours per fishway. Entrances will be out of criteria.

Not doing this inspection in mid-November may result in delays in getting the winter maintenance season started by 1 December and maintenance items may not be completed. Specific maintenance includes west entrance grating reattachment, west entrance weir wheel replacement and east exit weir 159-154 rehab and wheel replacement. Amount of available time will dictate how much of this list is accomplished.

Dates of impacts/repairs- 11/12/13

Length of time for repairs- Max 4 hours total.

Expected impacts on fish passage- There has been no recent fish counting at The Dalles during November, so data is limited. Data for The Dalles on Nov 12 from 2003-2007 showed an average of 58 Chinook, 28 Coho and 191 steelhead. Data for Bonneville on Nov 12 from 2007-2012 showed an average of 29 Chinook, 63 Coho and 42 Steelhead. Delays in starting winter maintenance dewatering activities may result in key fish related maintenance items not getting completed during this maintenance season.
