

**Confederated Tribes of the Umatilla Indian Reservation
Department of Natural Resources—Fisheries Program
Pacific Lamprey Research and Restoration Project**

PROJECT WORK PLAN

A key component to restoring lampreys to the Umatilla River as outlined in our approved restoration plan titled, *Restoration Plan for Pacific Lampreys (*Lampetra tridentata*) in the Umatilla River, Oregon*, is to collect adults for outplanting in the Umatilla River Basin. CTUIR proposes to collect up to 254 adult Pacific lamprey from NOAA staff that are already trapping at Bonneville. CTUIR staff would come to Bonneville Dam and pick up adult lampreys (that are not utilized by NOAA/UI research) weekly until target is met. Upon USACOE approval, CTUIR anticipates beginning this collection in May 2014 and continuing until last week of September or until target is met, whichever is first. We would utilize our 300 gallon fish transport tank for moving adults on and off the project. CTUIR has already coordinated with Mary Moser, Steve Corbett and Kinsey Frick to obtain adult lampreys through NOAA existing approved work at the project. FPOM already approved this work 2010-2013 and we request approval for 2014. CTUIR would work with other tribes to help facilitate their perspective collections as well.
