Dear Mr. Rose:

This is in response to your April 15, 2014 letter requesting approval to collect up to 254 Pacific lamprey (*Entosphenus tridentata*) from mid-May through August 2014. It is understood that this collection is for your project to restore *E. tridentata* to the Yakima River and other subbasins within the tribes' Ceded Lands. Your proposal states that the lamprey collected from Bonneville Dam will be used in research efforts in the Yakima River subbasin associated with adult passage at low head dams.

Please note, NOAA Fisheries and University of Idaho will be responsible for collecting lamprey and distributing lamprey not needed for research.

With respect to the work outlined above, your request is generally approved, provided you are able to obtain all necessary ESA and state, or tribal permits. No work may begin until permits, or an explanation as to why permits are not required, are on file with the Mr. Andy Traylor and Ms. Tammy Mackey.

Prior to beginning work, please arrange a meeting with Mr. Andy Traylor, 541-374-4020. You will need to provide a Project impact statement, activity hazard analysis, copies of permits, and a personnel list. Please remain in contact with Mr. Traylor throughout your time at the dam. There are many researchers and contractors working at the dam, please work to ensure good communication and cooperation between agencies and organizations.
