

**Confederated Tribes of the Umatilla Indian Reservation
Department of Natural Resources—Fisheries Program
Pacific Lamprey Research and Restoration Project**

PROJECT WORK PLAN

A key component to restoring lampreys to the Umatilla River as outlined in our approved restoration plan titled, *Restoration Plan for Pacific Lampreys (Lampetra tridentata) in the Umatilla River, Oregon*, is to collect adults for outplanting in the Umatilla River Basin. CTUIR/CRITFC proposes to collect up to 450 adult Pacific lamprey from behind the pickette leads at The Dalles Dam, and other highly coordinated, approved areas utilizing pot traps. CTUIR/CRITFC staff would come to The Dalles Dam and deploy pot traps in the East and North fishways behind the picket leads in an attempt to trap upmigrating adult Pacific lampreys. Trap placement will be chosen to avoid contact with any migrating salmonids. Traps would be checked daily. Trapped lampreys would be transported to a waiting 300 gallon holding tank supplied with oxygen and transported to one of our adult lamprey holding facilities, either South Fork Walla Walla or Minthorn Springs or held at the John Day SMF until we transported to our facilities. CTUIR anticipates collection to continue until we reach our yearly target of up to 450 adults. The USACOE's FPOM group approved this activity in 2010-2014 and we request approval for 2015. CTUIR/CRITFC would likely trap through October. CTUIR has already had initial coordinated with Tammy Mackey, Bob Cordie and Paul Keller regarding this work. CTUIR/CRITFC would work with other tribes to help facilitate their perspective collections as well.

PROJECT IMPACT STATEMENT

CTUIR has no anticipated impacts to the existing project activities. Measures will be taken to assure project safety. Latex gloves will be used when deploying and checking traps to minimize human smell in the fishways.
