Dear Mr. Martinson:

This is in response to your January 21, 2015 letter requesting approval for access to John Day Dam's Smolt Monitroing Facility (SMF) for the purposes of implementing the Smolt Monitoring Program. In addition to collecting and monitoring juvenile salmonids, as part of the Smolt Monitoring Program, you may also be collecting and holding fish for other researchers. Collecting and holding for others may only be conducted if those researchers have submitted their paperwork and received approval to access John Day Dam.

With respect to the work outlined above, your request is generally approved, provided you are able to obtain all necessary ESA and state permits. No work may begin until permits, or an explanation as to why permits are not required, are on file with the Mr. Eric Grosvenor and Ms. Tammy Mackey.

Prior to beginning work, please arrange a meeting with Mr. Eric Grosvenor, 541-506-7861. You will need to provide a Project impact statement, job hazard analysis, copies of permits, and a personnel list. Please send electronic copies of these documents to Mr. Grosvenor, Eric.Grosvenor@usace.army.mil\_and to Ms. Tammy Mackey, tammy.m.mackey@usace.army.mil\_

Please remain in contact with Mr. Grosvenor throughout your time at the dam. There are many researchers and contractors working at the dam, please work to ensure good communication and cooperation between agencies and organizations.
