Dear Mr. Statler:

This is in response to your May 9, 2017 letter requesting approval for access to Bonneville Dam's Adult Fish Facility (AFF) in order to collect 196 adult Pacific Lamprey for the purposes of translocation to the Snake River Basin. These fish will be transported to the Nez Perce Tribal Hatchery near Lenore, ID. Lamprey for translocation will be collected at Bonneville; trapping and holding of fish will be conducted by the Columbia River Inter-Tribal Fisheries Commission and will not be the responsibility of the Corps of Engineers.

With respect to the work outlined above, your request is generally approved, provided you are able to obtain all necessary ESA, state, and/or tribal permits. No work may begin until permits, or an explanation as to why permits are not required, are on file with Ms. Ida Royer and Ms. Erin Kovalchuk. You will be required to follow all protocols found in the current Fish Passage Plan (FPP) Appendix G - Protocols for Adult Fish Trapping Operations.

Prior to beginning work, please arrange a meeting with Ms. Ida Royer, 541-374-2541. Please remain in contact with Ms. Royer throughout your time at the dam. There are many researchers and contractors working at the dam, please work to ensure good communication and cooperation between agencies and organizations.
