Dear Mr. Tattam:

This is in response to your May 28, 2020 letter requesting approval for access to the Adult Fish Facility (AFF) Bonneville Lock and Dam to facilitate the sampling and tagging of adult summer Steelhead as part of the Adult Steelhead Migratory Routes Investigation. This work is anticipated to run from early July until September 30, 2020.

It is understood that you will be dual tagging and releasing A-run Steelhead to be tracked by acoustic receivers upstream of Bonneville, with a focus on the John Day Pool and McNary Dam. This work will be done in conjunction with Oregon State University (OSU) and coverage for work during warm water sampling periods is provided by US v Oregon. You will be tagging only while CRITFC already has the AFF in sampling mode, and will follow all pertinent sampling guidelines from Appendix G of the 2020 Fish Passage Plan.

With respect to the objectives outlined above, your request is approved, though please note that you will be responsible for coordinating your sampling activities in the AFF with CRITFC. This includes allocation of anesthetic tank usage.

Prior to beginning work, please arrange a meeting with Mr. Andrew Derugin, 541-374-3879. No work may begin until copies of all required permits are on file with Mr. Andrew Derugin, Andrew.g.Derugin@usace.army.mil and Mrs. Erin Kovalchuk, Erin.H.Kovalchuk@usace.army.mil.

Please remain in contact with Mr. Derugin throughout your time at the dam. There are many researchers and contractors working at the dam, please work to ensure good communication and cooperation between agencies and organizations.
