Dear Ms. Steingrass:

This is in response to the Oregon Department of Fish and Wildlife memorandum dated 18 December, 2020 requesting approval from the U.S. Army Corps of Engineers (USACE) to conduct sea lion hazing and capture activities at the Bonneville Project. This work will be conducted in conjunction with Mr. Scott Pearson of Washington Department of Fish and Wildlife, Mr. Joe Dupont of Idaho Department of Fish and Game, and Mr. Doug Hatch of the Columbia River Intertribal Fisheries Commission. The proposed activities have four objectives:

a. Capture and permanently remove California sea lions (CSLs) and Steller sea lions (SSL) from the Bonneville Dam area as permitted under Marine Mammal Protection Act (MMPA) Section 120(f) by NMFS for sea lion management in the lower Columbia River Basin.

b. Improve our understanding of salmonid and at-risk fish stock predation levels below Bonneville Dam.

c. Increase our sea lion food habits and prey genetics databases and assess food habits of sea lions present at Bonneville Dam.

d. Reduce depredation of fish, reduce sea lion presence, and resultantly limit the recruitment of new pinniped predators to the area below Bonneville Dam.

With respect to the objectives outlined above, your request is approved, though please note that Project assistance may be limited, depending on the activities already scheduled at the dam.

Please follow the guidance that the BiOp, NOAA, F/NWR/2011/05874, dated February 29, 2012 (available on the FPOM website) outlines with specific limits to sea lion bomb use and boat access within the BRZ for human and fish safety issues. This includes a 100ft minimum distance for boats from all project structures, a 150 foot minimal distance from main fishway entrances, no use of seal bombs from the boats within 300 feet from all fishways, floating orifices, B2CC or smolt monitoring facility outfalls, and no use of seal bombs within 150 feet of any shoreline or shallow water area. Seal bomb use is limited to 1-3 bombs per animal/ per hazing occurrence and no seal bombs in the BRZ when fish counts reach 1000 fish per day. Additional specifications are included in the BiOp.

Prior to beginning work, please arrange a meeting with Mr. Ben Hausmann, 541-374-4598. No work may begin until copies of all required permits are on file with Mr. Andrew Derugin, <u>Andrew.g.Derugin@usace.army.mil</u> and Mrs. Erin Kovalchuk, <u>Erin.H.Kovalchuk@usace.army.mil</u>.

Please remain in contact with Mr. Hausmann throughout your time at the dam. There are many researchers and contractors working at the dam, please work to ensure good communication and cooperation between agencies and organizations.
