Avian hazing at Snake River dams typically starts 1 April, as described in Appendix L of the FPP, which this year is Easter Sunday. APHIS has requested changing the start of hazing efforts at Snake River dams to Monday 2 April. This MOC is to request hazing at the four Snake River projects to start 2 April 2018.

Analysis of potential impacts to fish.

Smolt index values for 1 April in 2017 equated to about 0.04 to 0.06% for Chinook salmon migrants and 0.8 to 1% of steelhead migrants at Snake River projects.

Numbers of birds counted at the Snake River projects 1 April 2017 were; 1 gull and 22 cormorants at Ice Harbor, none at Lower Monumental, 70 gulls and 1 cormorant at Little Goose and 1 gull at Lower Granite Dam.

- a. Downstream migrants: negligible to minor
- b. Upstream migrants (including Bull Trout): none
- c. Lamprey: negligible
