MEMORANDUM FOR Biologist, Operations Division (CENWP-OD)

SUBJECT: Bonneville Project, Fishway and Fish Activities for <u>Week 18</u> of 2020, which covers the period from <u>26</u> <u>April – 02 May.</u>

1. OPERATION SUMMARY:

a. Daily average river flows ranged from 201.3 to 267.8 kcfs. Daily average powerhouse forebay elevation ranged from 73.8' to 74.8' msl. Daily average project tailwater ranged from 16.7' to 20.4' msl. Secchi disk measurements ranged from 6.0' to 7.0'. Daily average water temperature ranged from 52° to 54°F.

b. Daily average spill ranged from 132.7 to 133.6 kcfs.

C. Unit Operation. <u>PH2 remains the priority powerhouse</u>. Main unit drawdowns are measured every Monday and more frequently as needed.

3. RESEARCH:

- **a.** <u>Four Peaks Environmental Fish counting contract</u>: Daytime visual counting (0500 to 2100) began on 01 April. Fish counts can be viewed here.
- b. <u>PSMFC Smolt Monitoring</u>: Sample collections at the SMF began at 0700 on 02 March. Debris at the PDS and fish/debris separator was light to light-moderate consisting mostly of sticks. GBT examinations began on 19 April and are typically performed two days per week through spill. Results of this week's GBT examinations: 199 yearling Chinook and Steelhead plus one peamouth examined with no GBT symptoms observed. Nine steelhead one salmon fallbacks were observed this week. No fish collections for research purposes were conducted this week. More details can be found on the FPC web page.
- C. <u>USDA Pinniped hazing</u>: Deck-based hazing began 01 March.
- d. <u>CRITFC Pinniped hazing</u>: Hazing by boat began 01 March. Suspended indefinitely 20 March for social distancing purposes.

- On 01 May 2018, FG6-11 (Cascades Island) was found broken partially open. The diffuser shaft had broken away from the motor. Due to the subsidence issues at Cascades Island, repairs cannot occur until crane support is allowed in the vicinity. FG6-11 should be open at tailwaters ≥ 14.0'.
- On 18 August 2018, FG6-12 (Cascades Island) was found to be mechanically bound in the open position. FG6-12 should only be open with tailwaters ranging from 11.0'-33.0'. Due to the subsidence issues at Cascades Island, repairs cannot occur until crane support is allowed in the vicinity.
- On 27 March 2019, FG6-18 (Cascades Island) was found to be mechanically bound in the closed position. FG6-18 should be open with tailwaters > 12.0'. Due to the subsidence issues at Cascades Island, repairs cannot occur until crane support is allowed in the vicinity.

C. <u>Adult Fishways</u>.

(1) The AFF remains in service.

- (2) Sensor calibration occurred on 1 May.

d. Juvenile Fishways.

- (1) The ITS remains in service (auto-chain gates 3B, 6C, & 10B only).

e. Lamprey Fishways.


- (1) LPSs remain in service.
