MEMORANDUM FOR Biologist, Operations Division (CENWP-OD)

SUBJECT: Bonneville Project, Fishway and Fish Activities for <u>Week 02</u> of 2021, which covers the period from <u>03-09 January 2021.</u>

1. OPERATION SUMMARY:

- **a.** Daily average river flows ranged from 129.6 to 185.1 kcfs. Daily average powerhouse forebay elevation ranged from 73.8' to 75.3' msl. Daily average project tailwater ranged from 13.8' to 16.9' msl. Secchi disk measurements remained at 7.0'. Daily average water temperature ranged from 42-43°F.
- b. Daily average spill remained at 0.5 kcfs.
- **C.** Unit Operation. PH1 will remain the priority powerhouse until the end of February 2021 due to winter maintenance in PH2, Cascades Island fishway, and Washington Shore fishway. Main unit drawdowns are measured every Monday and more frequently as needed.

d. Fish Units. Second Powerhouse fish units provide attraction flow for the Washington Shore (WS) fish ladder.

<u>Fish Unit Outages.</u> Fish Units are periodically placed into reserve service (RS) to float trash when debris differentials become excessive and trash raking is not possible.

2. MAINTENANCE ACTIVITIES:

- **a.** Auxiliary Water System Closures.
 - FV 3-7 and 3-9 were closed for cleaning from 0745 to 0805 on 04 January.
 - FV 1-1 was closed for cleaning from 0825 to 0850 on 04 January.
 - FV 1-1 was closed for cleaning from 1243 to 1300 on 07 January.
 - FV 3-7 and 3-9 were closed for cleaning from 1320 to 1420 on 07 January.
 - PH1 OWS was placed in manual from 0853 to 0910 on 07 January.
- b. <u>STS/VBS Inspections</u>. STS's were removed on 16 December for annual winter maintenance activities.
- **C.** <u>Dewatering and Fish Salvages</u>. On 7 January, fisheries biologists entered Cascades Island fishway diffuser FG6-10 pit for fish salvage. 1 juvenile salmonid, 4 sculpin, and 4 juvenile shad were recovered in good

condition and released downstream at Hamilton Island boat launch.

3. RESEARCH:

- **a.** <u>Four Peaks Environmental Fish counting contract</u>: Daytime video counting (0400 to 2000) began on 01 December. Fish counts can be viewed <u>here</u>.
- b. <u>USFWS Lamprey Metamorphosis Study:</u> Juvenile lamprey researchers are onsite, and the work is underway.

4. FISHWAYS:

- a. Project biologists inspected 04 07 January.

C. Adult Fishways.

- (1) The Cascades Island Fishway went out of service and into orifice flow on 01 December.
- (2) The Washington Shore Fishway went out of service and into orifice flow on 01 December.
- (3) The AFF was taken out of service for the winter on 25 Nov.
- (4) Sensor calibration occurred on 05 January.
- (5) SLEDs are installed at all locations.

d. <u>Juvenile Fishways</u>.

- (1) The ITS remains in service (auto-chain gates 3B, 6C, & 10B only).
- (2) The hydro-cannon remains in service.
- (3) The B2CC was open from 0800 to 1300 on 05 January and opened again from 1015 to 1300 on 06 January to flush trash. Otherwise, B2CC remains out of service.
- (4) The DSM was placed out of service for annual winter maintenance at 1017 on 17 December.
- (5) STS removal for winter maintenance was completed on 16 December and will remain OOS through the end of February.

- e. Lamprey Fishways.
 - (1) LPSs remain out of service.
 - (2) The Bradford Island Wetted Wall (BIWW) remains out of service.
 - (3) The PH2 Lamprey Flume Structure (LFS) remains out of service.
 - (4) The AFF lamprey trap remains out of service.
 - (5) The CI Lamprey trap remains out of service.
- f. Avian Monitoring. Avian counts are recorded 01 April 31 October.
- **5.** WATER QUALITY MONITORING:
 - **a.** <u>Fishway Temperatures.</u> Temperature logs are no longer being taken this year; data collection will begin again 01 March, 2021.
 - b. Zebra Mussel Monitoring. No signs of colonization were observed this reporting week.
- **6.** CONSTRUCTION: Nothing to report.
- **7.** HAZMAT, SPILLS AND CLEANUP: Nothing to report.
- **8.** TELETYPES CURRENTLY IN EFFECT:
 - A teletype was sent out 30 December stating effective 1 January 2021 at 0001 hours, until further notice, the Bonneville Dam minimum tailwater elevation is 11.8 feet during all hours. The intent of this teletype is to provide sufficient tailwater elevation to protect the chum redds in the Ives/Pierce Island are during the egg incubation period.
