MEMORANDUM FOR Biologist, Operations Division (CENWP-OD)

SUBJECT: Bonneville Project, Fishway and Fish Activities for <u>Week 26</u> of 2021, which covers the period from <u>20</u> to 26 June 2021.

1. OPERATION SUMMARY:

- a. Daily average river flows ranged from 180.2 to 219.6 kcfs. Daily average powerhouse forebay elevation ranged from 74.3' to 75.1' msl. Daily average project tailwater ranged from 15.2' to 17.7' msl. Secchi disk measurements ranged 5.0' to 7.0'. Daily average water temperature ranged from 62 to 66°F.
- b. Daily average spill ranged from 95.2 to 95.9 kcfs. Summer spill season began on 16 June and will continue through 31 August in accordance with FOP guidelines.
- c. <u>Unit Operation</u>. **PH2** remains the priority powerhouse. Main unit drawdowns are measured every Monday and more frequently as needed.

d. <u>Fish Units</u>. Second Powerhouse fish units provide attraction flow for the Washington Shore (WS) fish ladder.

<u>Fish Unit Outages</u>. Fish Units are periodically placed into reserve service (RS) to float trash when debris differentials become excessive and trash raking is not possible.

2. MAINTENANCE ACTIVITIES:

- a. Auxiliary Water System Closures.
 - FV 3-7 (Bradford Island) was placed in manual and pinched down to reduce flow in the BI AWS to prevent blown diffuser grating and further damage to FG 3-3. FG 3-4, FG 3-5, and FG 3-6 are all OOS due to mechanical failure. These settings for the A-Branch AWS and diffusers will likely remain until the problems can be addressed during the 2021-2022 winter maintenance period. - b. <u>STS/VBS Inspections</u>. Nothing to report.
- c. Dewatering and Fish Salvages. Nothing to report.

3. RESEARCH:

- a. <u>Four Peaks Environmental Fish counting contract</u>: Daytime visual counting (0500 to 2100 PDT) began on 01 April. Night video (2100 to 0500 PDT) counting began 15 May. Fish counts can be viewed <u>here</u>.
- b. <u>USFWS Lamprey Metamorphosis Study</u>: Juvenile lamprey researchers are onsite, and the work is underway.
- c. Pacific States Marine Fisheries Commission Smolt Monitoring: Sample collections at the SMF began at 0700 on 02 March. Debris at the primary dewatering structure (PDS) and fish/debris separator was light consisting mostly of aquatic macrophytes and a few sticks. Gas Bubble Trauma (GBT) examinations began on 10 April and are typically preformed 2 days/week through the end of spill season. Results from this week's GBT examinations: 200 yearling Chinook, subyearling Chinook, and steelhead examined with no GBT symptoms observed. Fallbacks observed this week: one steelhead. No fish collections for research purposes were conducted this week. More details can be found on the FPC web page.
- d. <u>USDA Pinniped and Avian Hazing</u>: Deck-based hazing continues.
- e. State Agency Pinniped Trapping: Sea lion trapping has concluded for the spring season.
- f. WDFW/ PSMFC Pikeminnow Sampling: Hook and line angling activities continue for Northern Pikeminnow within the BON BRZ as a constituent of Gas Bubble Trauma (GBT) monitoring.
- g. <u>CRITFC Adult Salmonid Sampling</u>: Adult Salmonid sampling in the AFF began on 20 April and typically occurs 5 days per week.

4. FISHWAYS:

- a. Project biologists inspected 20 to 26 June.
- b. Fish Passage Plan observations.

- FV 3-7 (Bradford Island) was placed in manual and pinched down to reduce flow in the BI AWS to prevent blown diffuser grating and further damage to FG 3-3. These settings for the A-Branch AWS and diffusers will likely remain until the problems can be addressed during the 2021-2022 winter maintenance period.
- FG 3-4 (A-Branch) was found mechanically bound and unable to move from the "almost closed" position in December of 2020. This diffuser will likely remain in this position until the 2021-2022 winter maintenance period.
- FG 3-5 (A-Branch) was not operating correctly on 07 June 2021 and was banging heavlily underwater due to an assumed broken fish gate. To prevent futher damage to the fishway and equipment, a clearance has been issued for FG 3-5 to be closed and taken out of service until the winter maintenance period.
- FG 3-6 (A-Branch) was found mechanically bound in the closed position on 07 June 2021. This diffuser will likely remain in this position until the 2021-2022 winter maintenance period.

c. Adult Fishways.

- (1) The AFF remains in service.
- (2) Sensor calibration occurred on 22 June.
- (3) SLEDs are installed at all locations.
- (4) Cascades Island Fishway and Washington Shore Fishways were put into "Shad Mode" on 01 June.
- (5) Bradford Island Fishway was put into "Shad Mode" on 02 June.

d. <u>Juvenile Fishways</u>.

- (1) The ITS remains in service (auto-chain gates 3B, 6C, & 10B only).
- (2) The hydro-cannon remains in service.
- (3) The B2CC remains in service.

- (4) The DSM remains in service.
- (5) STS's remain in service.

e. Lamprey Fishways.

- (1) BI, CI, and WA Shore LPS's remain in service.
- (2) The Bradford Island Wetted Wall (BIWW) remains out of service.
- (3) The PH2 Lamprey Flume Structure (LFS) was remains in service.
- (4) The AFF lamprey trap remains in service.
- (5) The CI Lamprey trap remains in service.
- f. Avian Monitoring. Avian counts are recorded 01 April 31 October.




Figure 1. Average fishway temperatures for 20 to 26 June.

- b. Zebra Mussel Monitoring. No signs of colonization were observed this reporting week.
- **6. CONSTRUCTION:** Nothing to report.
- 7. HAZMAT, SPILLS AND CLEANUP: Nothing to report
- 8. TELETYPES CURRENTLY IN EFFECT:
 - A teletype sent out on 11 June stating effective 16 June at 0001 hours through 31 August at 2359 hours, Bonneville Dam is to operate in accordance with the 2021 Fish Operations Plan to provide summer spill for fish passage. Please see teletype BON R 061121 1732 for more details.
 - A teletype sent out on 11 June requested Bonneville Pool operate within a 1.5-foot band, hard constraint from 0600 on 16 June to 1800 on 19 June and from 0600 on 21 June to 1800 on 24 June. The goal of this operation is to limit pool fluctuation for the treaty fishery to avoid debris in fishing nets, reduce rapid water level drops that may entangle nets, minimize boat access problems, and avoid nets being torn from their anchors.  - A teletype sent out on 15 June provided guidance for summer spill caps for MCN, JDA, TDA, and BON starting at 0001 on 16 June and until further notice. Please see teletype BON R 061521 1307 for more details.
