6 Tower-to-Tower, 6 spillway (1 failed 23 August,) 4 Navlock and 4 PH lines are missing out of 125 grid's total. They will be reinstalled for the 2018 passage season.

Operations:

JD South Fishway in service with two AWS Turbines and meeting all FPP criteria since 3/3/17.

JD North Fishway in service with all 6 AWS pumps available and meeting all FPP criteria since 1/19/17.

MU Gatewell Drawdowns: weekly or more frequently as necessary.

Maintenance:

JBS Tainter Gate in manual mode due to the Channel's sensor failure since 8/27. Shortage of JD O&M funding may result in a longer OOS.

Trashrack Crane was repaired/ returned to service on 6/01.

JD STS crane's emergency repairs were all completed in February with the minor glitches/ adjustments continuing. The crane remains in a risky operational condition until it's replaced with a brand new machine. However, the \$ 5 million for its replacement is not yet available.


Calibration: All gauges/ sensors are within the criteria of 0.3'.

All tribal lamprey trapping successfully ended on 8/18/17.

WDFW angling crew continues the pikeminnow removal from JD PH tailrace (fishing from PH deck) since 5/15. Great catches with 3,332 NPM total by 9/03. Adult PIT antennas' installation at JD South Fishway finished on 23 Feb. Both ladders' antennas in service with temporary power sources. Phase 2 support contract to install building/ office spaces plus electrical and Gorgenet hookups underway since 7 August.

JDA Collection Channel Velocity


