SMOLT MONITORING FACILITY

Operation:

SMF continues in service, and in criteria since 13 March 2019.

Limited, twice a week sampling (Mondays and Thursdays) commenced after the JD forebay temperature reached 70 F on 25 July.

Maintenance:

No current maintenance issues of any kind. Planning for the upcoming winter's SCADA update underway.

ADULT FISHWAYS & TW AVIAN GRID

Birds:

USDA gull hazing ended on 31 July 2019. Very few gulls were present in the JD tailrace BRZ but a recorded number of white pelicans, up to approximately 300-400 per inspection, were observed in July. The white pelicans numbers have been declining since mid August. See Bird Count tab for details.

All 125 avian lines in place without any deficiencies.

Operations:

Monthly trash raking of the JD turbine intakes was completed in the last week of July. Very little debris was found.

MU Gatewell Drawdown All MUs trashrack differentials are 1.5' or below according to twice a week inspections.

Maintenance:

JD South Fishway continues operating with two AWS turbines (No. 1 & 2) since early April. AWS turbine No. 3 waiting for the replacement thrust bearing which is on order/ in contracting (at approx. \$ 20 K.)

JD South Fishway Collection Channel's gratings ROV inspection was completed on 8/14 with help of Mr. Jeff Randall, TD Fisheries. All gratings were found in place and properly attached without any brackets/bolts missing.

JD North Fishway continues operating in criteria. However, 2 out of 6 its ASW pumps are OOS due to auto greaser and oil leaks issues since mid June.

JD Maintenance is planning for an unstocking inspections to determine the undelaying causes.

Calibration: All gauges/ sensors are within the criteria of 0.3' .

Research:

Four Peaks Env. adult salmonids counting at both JD fishways continues since 1 April 2019. The night video counting is ongoing as well.

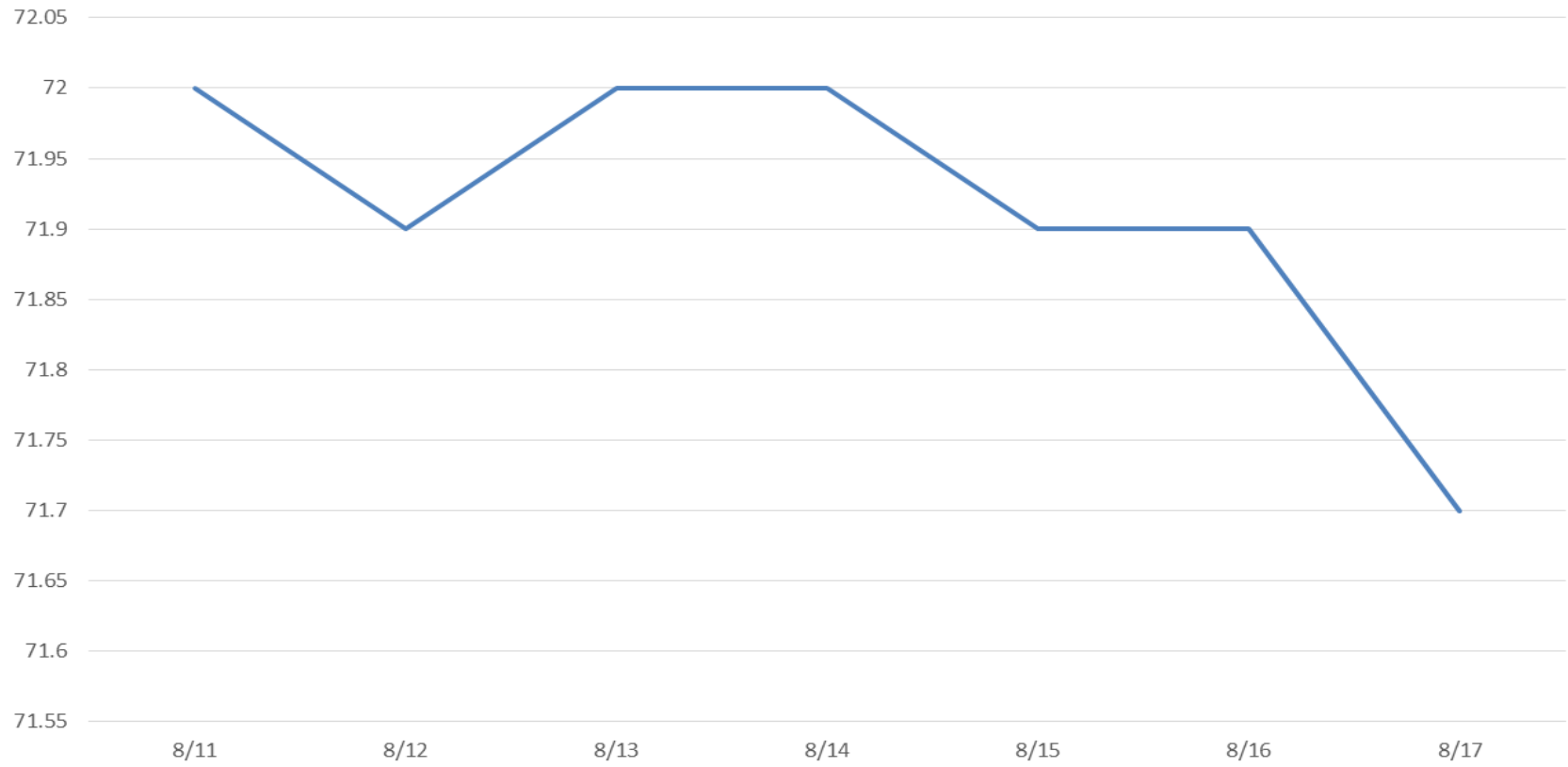
Washington F & W NPM dam angling continues since late April with the season total of 1,835 fish as of August 18.
