SMOLT MONITORING FACILITY

Operation: SMF is in sampling mode since 3/31 AM. Daily 24 hrs smolt sampling by PSMFC crew since 4/1.

JD Fisheries crew started regular 24/7 swing shift schedule as required by FPP; it will continue this until the end of sampling season on 9/15.

Debris: Moderate to heavy; primarily tumbleweeds with some sticks, branches, and wooden debris.

Maintenance: JD Electrical continues replacing burnt out light bulbs in the SMF parking lot and on the walkway behind the facility.

Research:

Battelle's collection, tagging and holding of juvenile salmonids at JD SMF lab underway. Their spring activities will continue 7 days a week, through the

end of May.

OTHER ISSUES:

JOHN DAY

BIRDS: see the Avian Numbers tab. We report all species and locations, but in reality only gulls in the tailrace BRZ are relevant at JD.

USDA hazing from a boat started on 4/17; one 8 hrs shift, 7 days a week will continue through the end of July. A slight increase in numbers of gulls PM after hazing stops, but almost all are flying downstream of the avian tailrace BRZ grid. Gull predation at JD continues to be estimated as minimal. 124 out of 125 total primary lines are intact/ in placed.

Operations:

JD North Fishway is in regular service and meeting the FPP criteria.

JD South Fishway in regular service and meeting the FPP criteria.

Maintenance:

Oil leak was found at MU 2 on 5/1 and its head gates were installed immediately. Tail logs were installed on 5/5, scroll case was dewatered on 5/6 and draft tube on 5/12. See JD MU2 Oil Spill MFR for more info.

JD North AWS pumps - five out of total six are available for service since 4/11. AWS pump # 4 continues in OOS status due to its lower bearing issues.

JD Engineering/contractor continue with its repairs.

Calibration: 5/14/2014 All sensors were within the criteria of 0.3'.

Gatewell Drawdown: 5/11/2014 and 5/14/2014 Three measurements above 1.0' on 5/11 and none on 5/14.

Research:

JD Fisheries coordinating with research groups for the upcoming 2014 studies:

PSMFC/WDFW dam angling for the pikeminnow will occur from the JD tailrace deck same as in the last few years.

Oregon DFW pikeminnow crew will survey JD Forebay BRZ (Oregon side) with electroshocking boat in May. BRZ entry permit is pending.


U of I Testing of JD North LPS (Lamprey Passage System) preparing for their passage season's work starting in June 2014.

JD Summer Juvenile Salmonids passage survival will start in June. PNNL continues collecting and tagging of fish at JD SMF for the McNary Spring passage survival.

2014 Adult Salmonids counting started at both JD Fishways by the Normandeau crew on 1 April as required by FPP.

Adult Salmonids Radio telemetry evaluations are ongoing at both JD adult fishway. University of Idaho crew is in charge of detecting of all adult adult salmonids, which were tagged and released at Bonneville Dam.

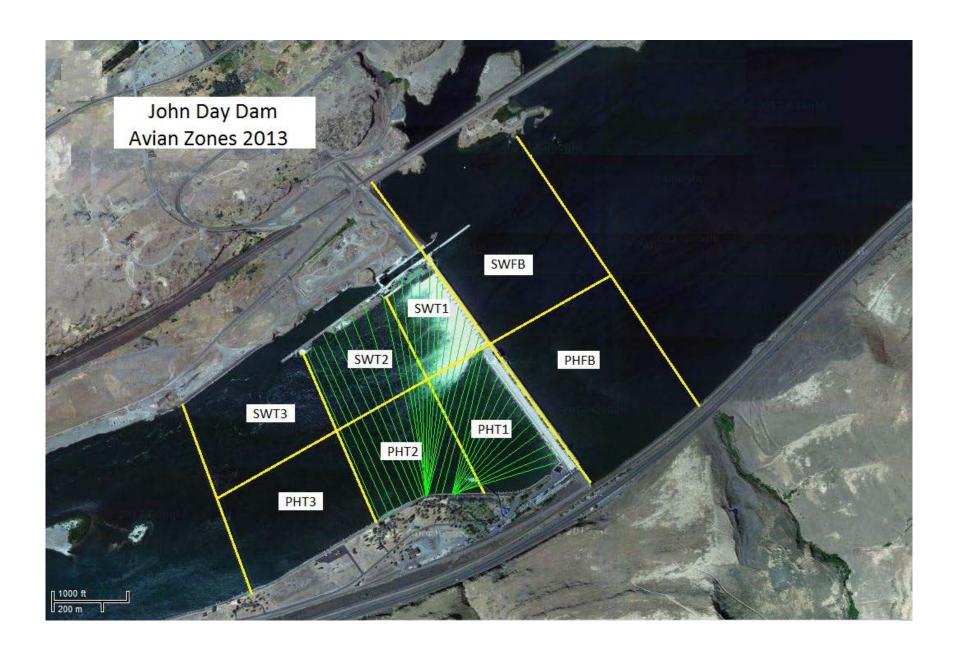
