## **OTHER ISSUES:**

### **JOHN DAY**

BIRDS: see the Avian Numbers tab. We report all species and locations, but in reality only gulls in the tailrace BRZ are relevant at JD.

Avian line # 26 was found failed/its end in the water on 9/1. This is shore- to-shore line and immediately adjacent to the previously missing # 27.

JD Engineering preparing SOW for a contract, which is expected in March '15; funding by special CRFM \$.

## Operations:

JD North Fishway is in regular service and meeting the FPP criteria.

JD South Fishway in regular service and meeting the FPP criteria.

Bay 2, 1.6 kcfs daylight spill from Bay 2 continues daily, September through November to provide additional attraction to JD North Entrance.

## Maintenance:

JD North AWS pumps - five out of total six are available for service since 4/11. AWS pump # 4 continues in OOS status due to its lower bearing issues.

JD Engineering/contractor continue with its repairs.

Calibration: 10/10/2014 All sensors were within the criteria of 0.3'.

JD South Fishway's bay 19 tailrace sensor was determined erratic/failed on 7/22 and TR'd immediately. JD Electrical found it clogged up by debris and cleaned it up on 7/30. Awaiting for a new sensor to replace it. JD Fisheries takes frequent manual measurements to keep the fishway in criteria.

Gatewell Drawdown: 10/12/2014. No units measured greater then 1.3 ft of differential for this reporting week debris loading is light...

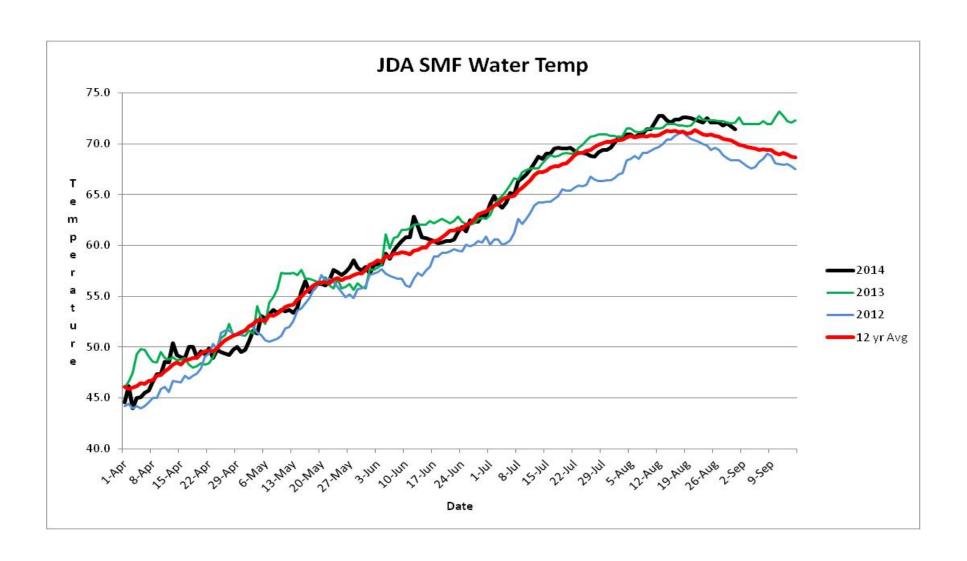
#### Research:

U of I Testing of JD North LPS (Lamprey Passage System) completed for 2014 season on 1 October. LPS will be shut down until the next June, 2015. 2014 Adult Salmonids counting by Normandeau Ass. continues through October 31 as required by FPP.

Adult Salmonids Radio telemetry evaluations are ongoing at both JD adult fishway. University of Idaho crew is in charge of detecting of all adult salmonids, which were tagged and released at Bonneville Dam.
