OTHER ISSUES:

BIRDS: see the Avian Numbers tab. We report all species and locations, but in reality only gulls in the tailrace BRZ are relevant at JD. Very high number of gulls, cormorants and grebes (> 500,) but it is apparent that they are primarily feeding on the abundant juvenile shad. Avian line # 26 was found failed/its end in the water on 9/1. This is shore- to-shore line and immediately adjacent to the previously missing # 27. JD Engineering preparing SOW for the re-installation contract, which is expected in March '15; funding by special CRFM \$.

Operations:

JBS continues in service for kelts fallback protection through 12/15.

JD North Fishway OOS for annual maintenance since 11/29, after 6 PM. Intensive testing of AWS pumps by Engineering and contractor occurred 12/2-6. As of 12/10 five out of six AWS pumps are available. Repair work on pump 4 continues; pump 3 has vibration issues and should be the last in service. RTS is 12/18.

JD South Fishway in regular service and meeting the FPP criteria. Its dewatering is scheduled for 1/7/2015.

Maintenance:

BPA Line 1 (MU 1-4) planned/replacement outage started on 10/21. RTS is 12/5/14.

JD North upper was successfully dewatered on 12/2. There were only a few salmonids requiring salvage; one adult steelhead and 10 juveniles were bagged and released back into the tailrace in excellent condition. There were approx. 40 adult lamprey salvaged, and 20 more pushed into tailrace in excellent condition. Last, but not the least one sturgeon, 3 feet was pushed into tailrace in excellent condition. There were no morts of any kind. JD North' entrance/ lower diffuser gratings were ROV inspected, in house on 12/4. All gratings were rock solid and properly attached.

JD North AWS pumps - five out of total six are available. AWS pump # 4 continues in OOS status due to its lower bearing issues.

COE Engineering/contractor continued with the intensive AWS pumps testing and repairs on 12/2-6.

Calibration: 10/20/2014 All sensors were within the criteria of 0.3'.

JD South Fishway's bay 1 & 19 tailrace failed back in July, 2014 and were TR'd immediately. Waiting for the new sensors (on order) to replace them.

JD Fisheries crew takes frequent manual measurements/ makes adjustments, which is more than satisfactory to meet the criteria this time of year.

Gatewell Drawdown: 11/23/2014. No units measured greater then 1.3 ft of differential, debris loading is increasing.

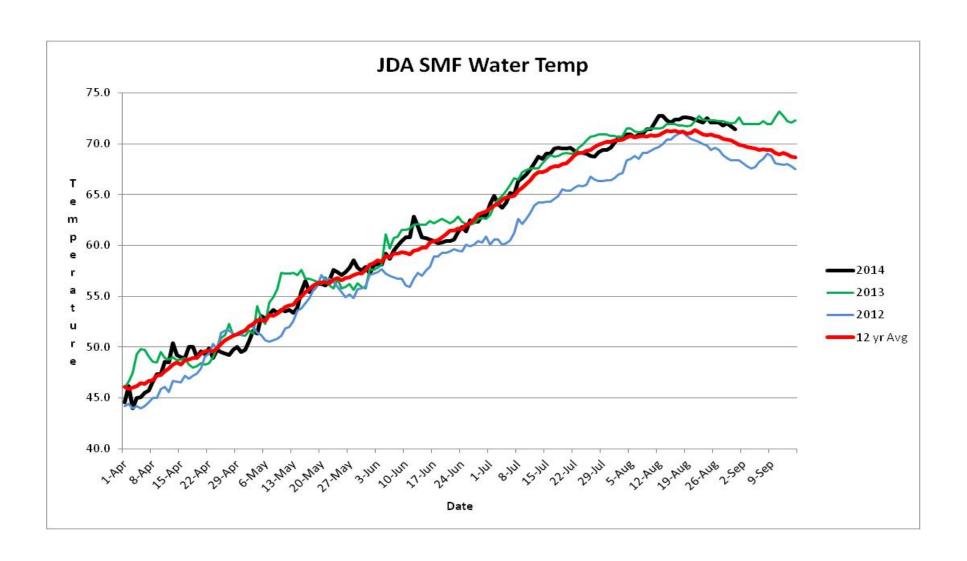
Research:
