Operation:

SMF in sampling mode since 3/31 AM. 24 hrs/ 7 days a week sampling by PSMFC as required by FPP.

JD Fisheries crew continues 24/7 swing shift schedule as required by FPP; it will continue this until the end of sampling season on 9/15.

OTHER JOHN DAY ISSUES:

Birds:

see the Avian Numbers tab. We report all species and locations, but in reality only gulls in the tailrace BRZ are relevant at JD.

USADA avian hazing from a boat began 4/16. Typical hazing shifts are 06:00 - 14:30 and as there are almost no gulls inside or even near of BRZ during that time. But their afternoon presence has been steadily increasing; the number of gulls has reached up to 100, mostly on the edge of JD avian grid.

Operations:

JD North Fishway in regular service; 5 out of 6 AWS pumps are available. Repair work on pump 4 continues; pump 3 has vibration issues and should be the last last in service. AWS pumps tripped due to unknown computer program/ control issues and all were OOS for approximately 20 minutes on 5/18 AM. Similar, short outages occurred twice the previous week; an overall impact on fish passage at JD North is minimal. An investigation by Portland's engineers underway.

JBS in regular service since 3/27.

JD South Fishway in regular service with 3 AWS Turbines; it is meeting the optimal FPP criteria.

MU Gatewell Drawdowns: Differentials are checked Wednesdays and Sundays; all gatewells were in criteria.

Maintenance:

JD North AWS pumps: five out of total six are available. Repair of AWS pump # 4 by a contractor started on 1/26 & is ongoing.

An HVAC contractor inspected the two AC units at JD N AWS Pumps Substation on 5/26. Both units were found to be in good condition; their performance issues have been due to the dirt and debris accumulation on the heat exchanger coils. They will require more frequent, deep cleaning with pressurized water. Currently one AC unit is in service and the second awaits a few control board parts, which are expected within a few weeks and on time before the hot weather arrives.

Calibration: All gauges/ sensors are within the criteria of 0.3'.

Research:

2015 Adult Fish Counting by Normandeau Associates commenced on 1 April, 2015 and will continue daily through 1 November.

Lamprey trapping and collection of adults & juveniles for various tribal and non-tribal studies are currently coordinated by JD Fisheries. Expected to commence in early June.

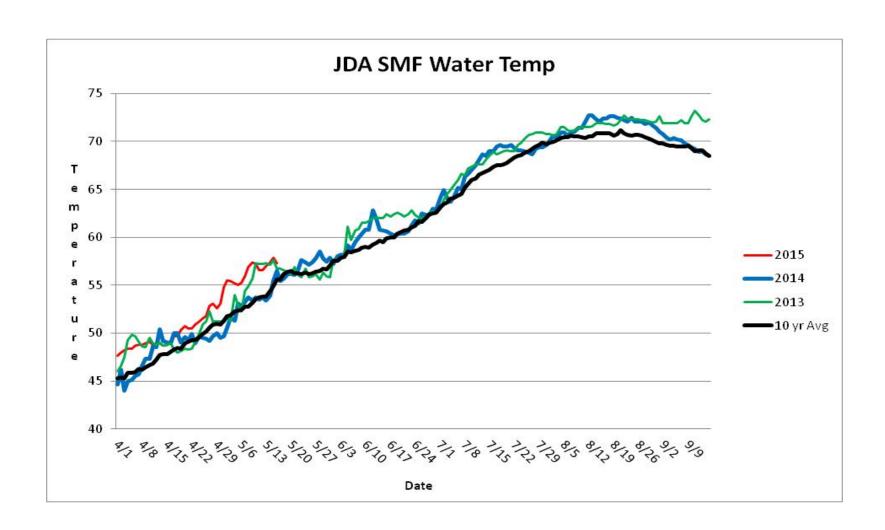
Dam angling to remove NPM from JD PH tailrace, by a crew from Washington F&W underway.

JD North LPS monitoring by FFU crew continues but with only a few adult lamprey collected and moved into the forebay.
