SMOLT MONITORING FACILITY

Operation:

OOS since 12/5/19. Planned RTS 4/1/2020.

Maintenance:

All AWS pipes winterized since early early December 2019. Winter maintenance of SMF hardware underway.

SMF SCADA update underway and is to be completed by 1 March 2020. JD Electricians are bench building the new control pannels to be installed in February.

Portland District's Electrical Engineers will be responsible for loading of new software and testing to assure all components are working properly.

ADULT FISHWAYS & TW AVIAN GRID

Birds:

Winter birds only without much impact on JD fish passage. See Bird Count tab for details.

All 125 avian lines in place without any deficiencies.

Operations:

JD South Adult Fishway was taken oos for Winter maintenance on 24 January.

JD North Adult Fishway RTS on 01/23/20. Dewatering pump 7 was re-installed with brand new components which will make the future dewaterings of lower fishway easier and less costly. JD Maintenance continue repairs of AWS fish pump 4. It's rts is unknown due to its serious issues.

JBS was dewatered on 9 Jan for Winter maintenance and scada upgrade

MU Gatewell Drawdown All MUs trashrack differentials are 1.5' or below according to twice a week inspections.

Maintenance:

JD South Fishway oos on 24 Jan. The thrust bearing on turbine 3 has been replaced and the turbine is ready to return to service.

Joint repair work on the SFL exit control section is ongoing.

JD North Fishway returned to service on 1/23. Pump 3 has returned to service, pump 4 has been pulled for maintenance.

NFL LPS water supply pumps were pulled and inspected. No defencies where found and the supply pumps where reinstalled.

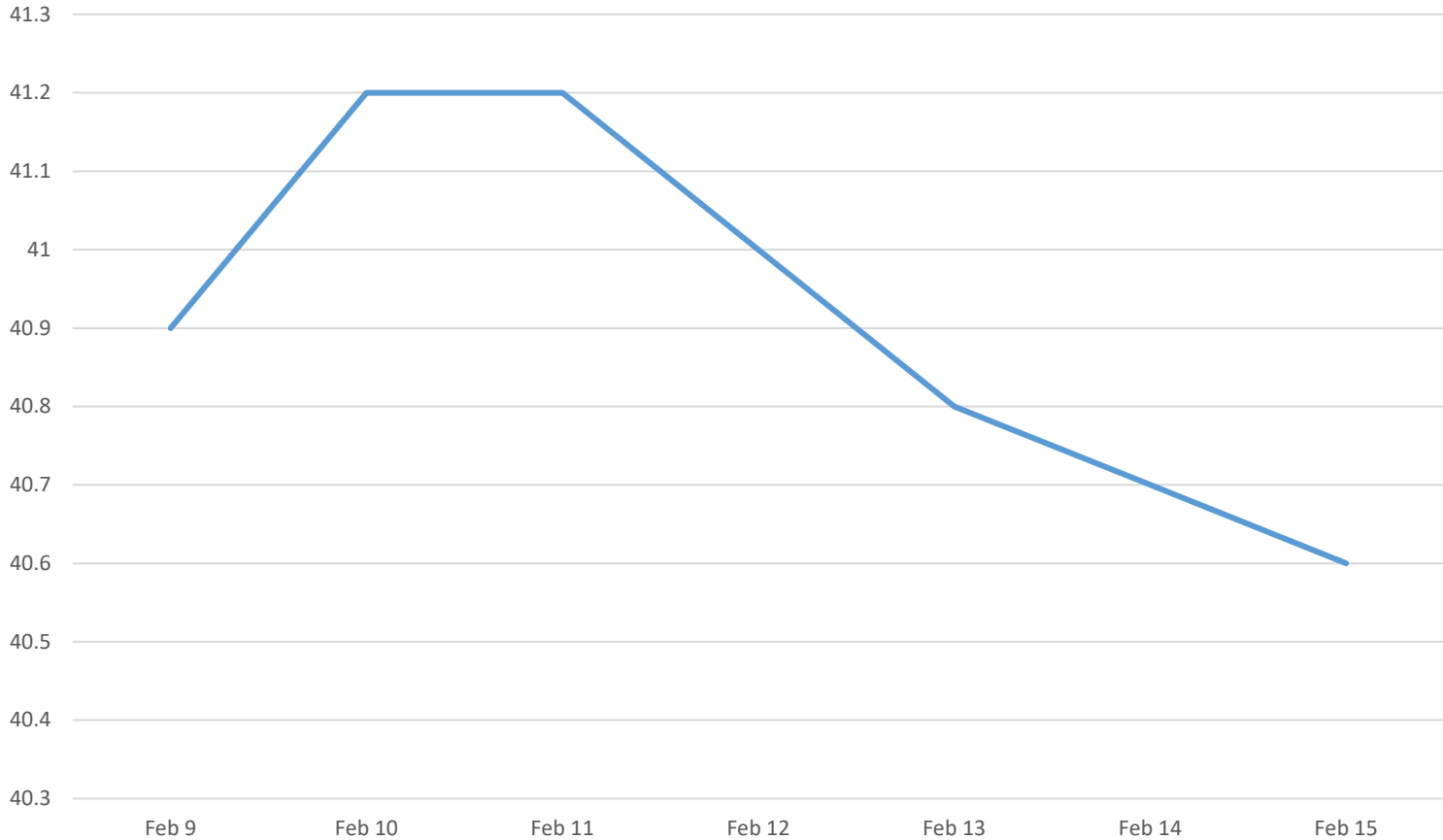
Calibration: All gauges/ sensors are within the criteria of 0.3'.
