JD South Fishway rts on 27 Feb. The thrust bearing on turbine 3 has been replaced and the turbine is ready to return to service. Joint repair work on the SFL exit control is completed.


JD North Fishway's pump 4 has been pulled for maintenance. Pump 1 breaker issue was resolved and is available.
