### **Smolt Monitoring Operations:**

Condition sampling started 4/01/2020 and with COVID-19 restrictions, Oregon and Washington stay at home orders, and USACE limited staffing levels, the SMF will continue limited conditioning sampling (every other day) until further notice. River temperatures have reached 70 degrees and sampling will now be Mondays and Thursdays (as per FPP).

### **Maintenance:**

SMF SCADA update completed 17 March 2020. JD Electricians are working on SCADA programming and controls. Slowed by COVID-19 availability  
JD North Fishway's pump 4 has been pulled for maintenance. - JD Maintenance continue repairs of AWS fish pump 4. RTS has yet TBD.  
Calibration - All gauges within the 0.3' criteria. However NE-1, NE-2, Bay 19 tw, and Bay 19 ch sensors OOC - Running in manual mode (0 out of criteria inspections). These OOC are believed to be related to the unfinished SCADA upgrades (lack of comms)

### **Bird Data:**

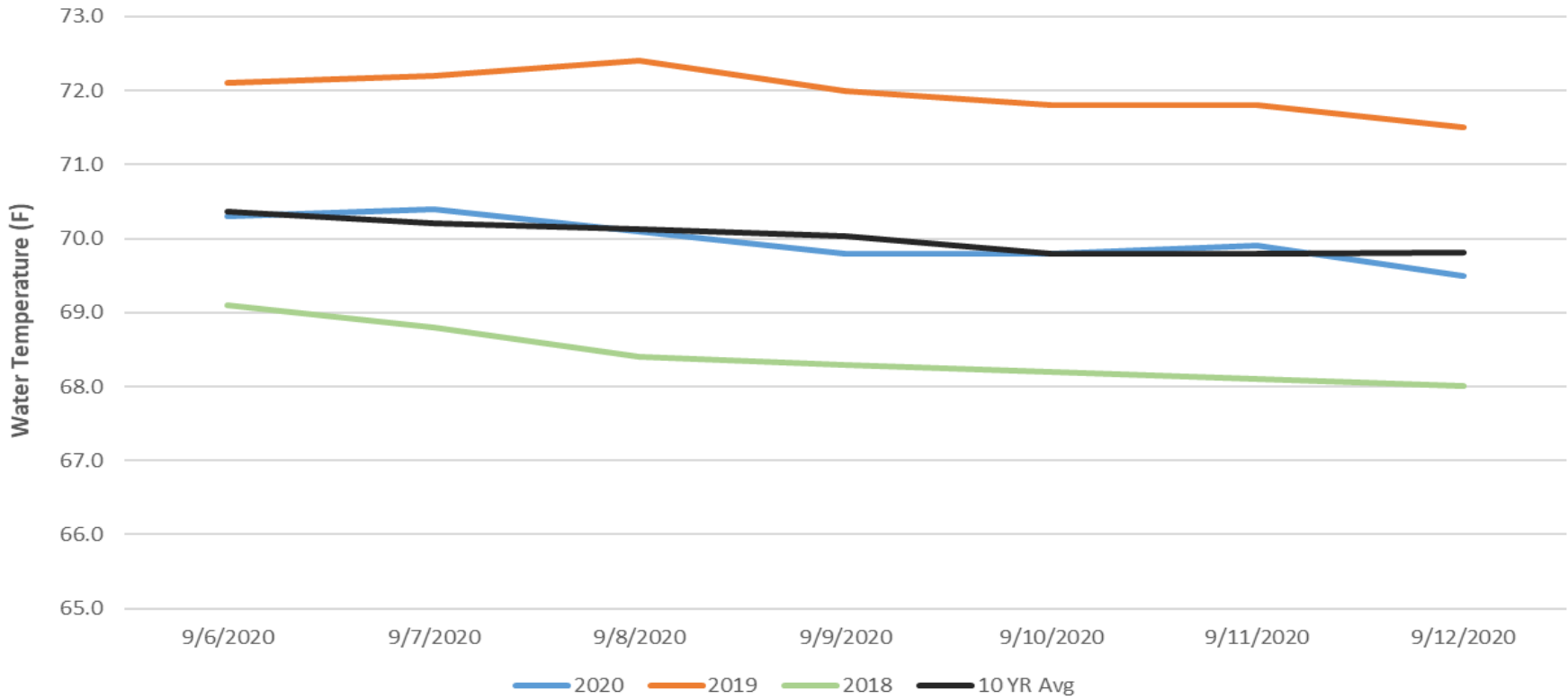
Few foraging gulls this week, decreasing number of foraging pelicans (see 'Bird Count' tab for details).

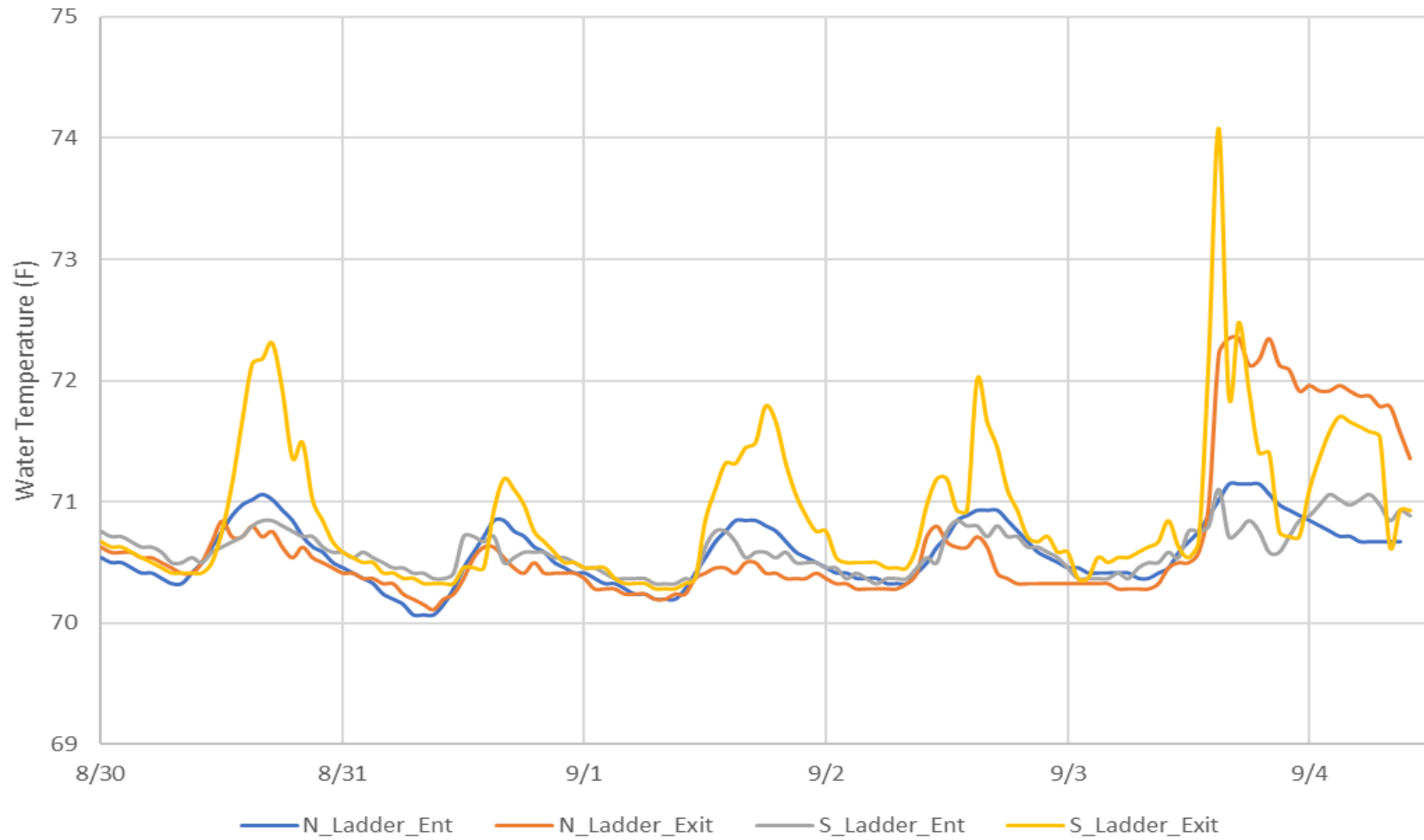
