Bird Data:

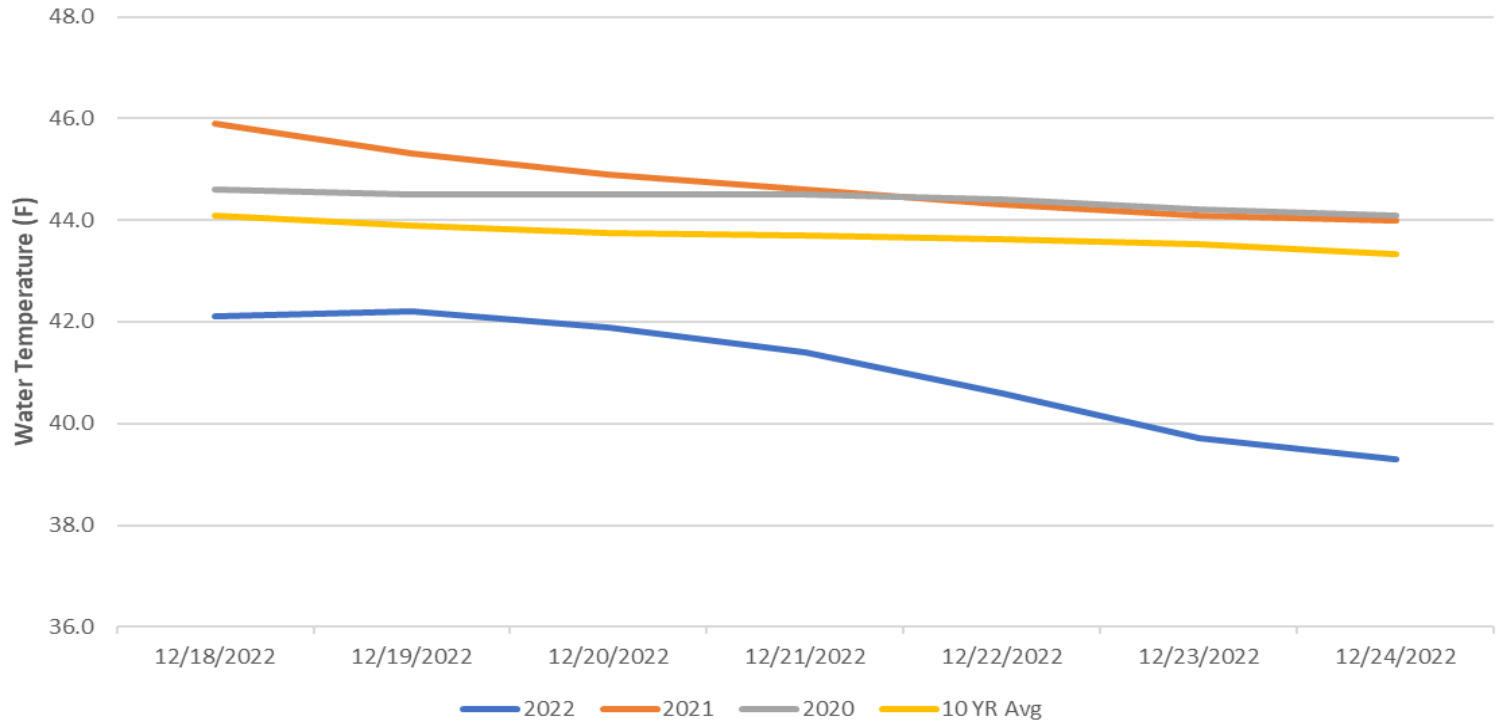

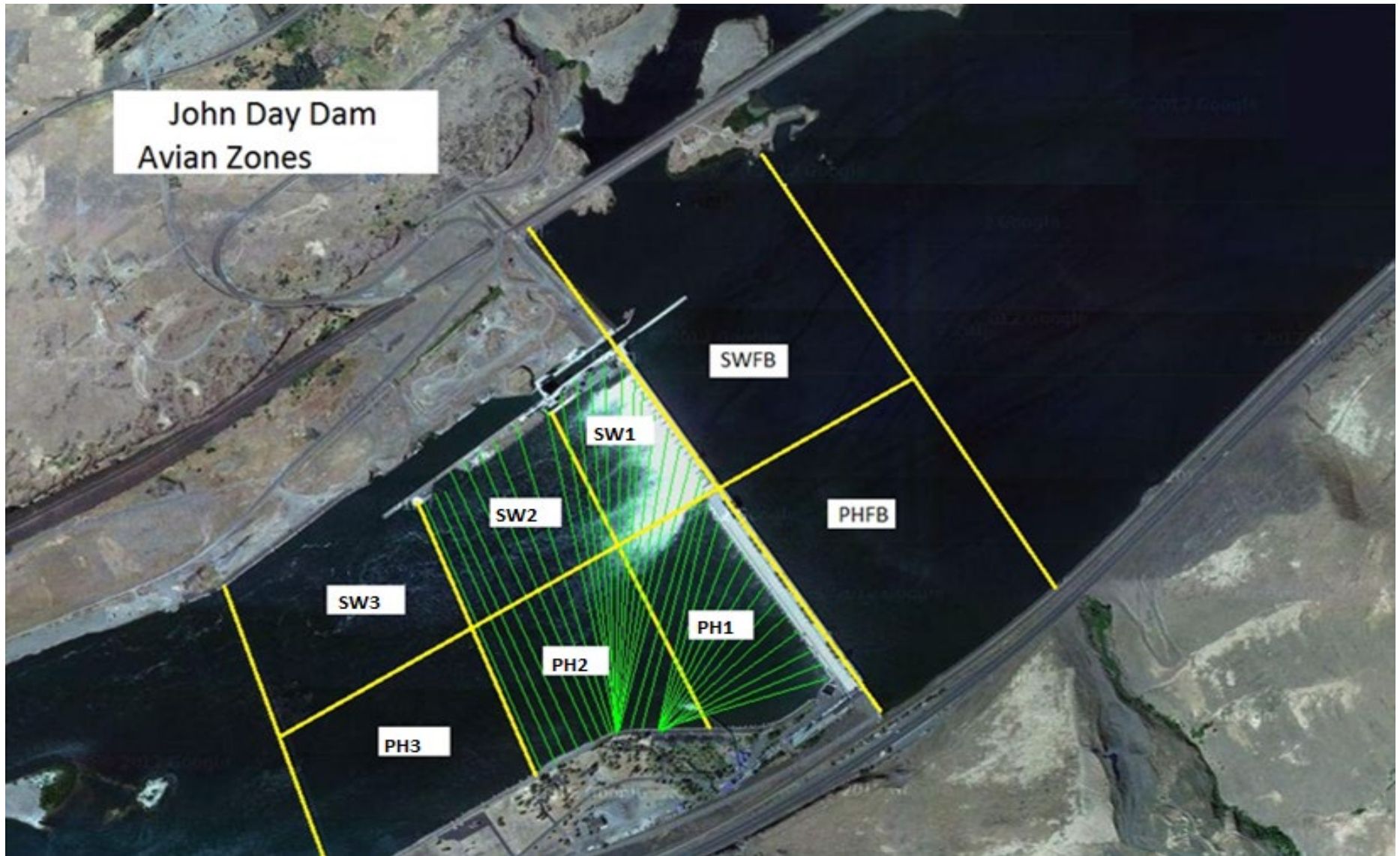

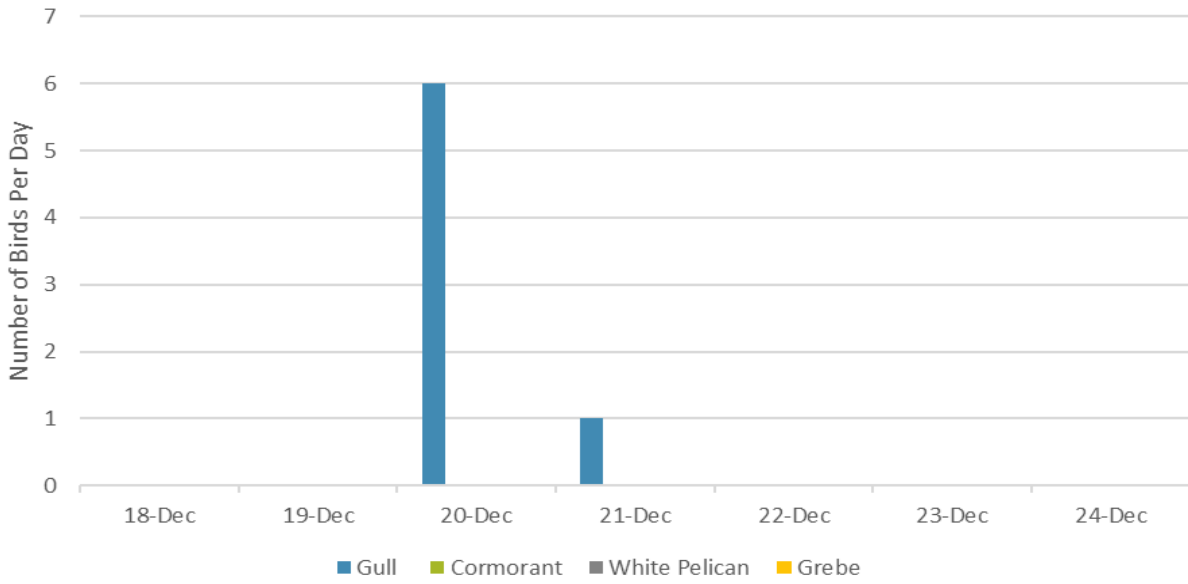
