Fisheries Related Operations

Smolt Monitoring Operations:

Smolt Monitoring Facility started the 2023 sampling season on April 3rd for condition monitoring only. From April 3 - June 15 condition sampling occurs 5-days/week (Monday-Friday) from approximately 0700-1300 or until the target of 100 fish of the predominant species has been reached. From June 16 - September 15 condition sampling will occur 3-days/week (Monday, Wednesday, Friday) from approximately 0700-1300 or until the target of 100 fish of the predominant species has been reached. High water temperature protocol goes into effect when water temperatures exceed 70F.

Adult Ladder Operations:

NFL is operating in criteria.

SFL turbine #2 RTS 3/20 @ reduced RPMs (55 RPMs) to prolong the repairs. SFL turbine #3 OOS (Philadelphia gear inspected on 2/22 and recommended FOOS - See 23JDA03) - Funding awarded (RTS-Unknown). FOG's removed

Ladders switched to shad mode on 5/30.

Maintenance:

NFL AWS pump #4 is OOS with an unkown RTS date (see 21JDA02). NFL AWS pump #2 has a failed RTD sensor that keeps it from reading an accurate temperature on the lower bearing (occured 4/22/23). Therefore, there is no overheat fail safe and it is being run as a last on first off pump (the pump will need to be unstacked to repair the sensor). NFL AWS pump #3 is being troubleshot and gives a gearbox oil low flow alarm (occured 5/26/23). It is believed the alarm occurs on either startup or shutdown. Once the alarm is acknowledged it can run withouth issue until it is shutdown again.

Calibration: All gauges within the 0.3' criteria.

Bird Data:

Pelican foraging is increasing within the tailrace (average ~29/inspection), Grebe numbers are holding steady in the forebay (~6), Gull numbers decreased this week with most foraging activity located in PH3 and SW3 zones (from ~25/inspection to ~2/inspection).

There are ~100 pelicans hanging around Preacher's Island

19 of 125 avian lines down, in contracting phase for replacement of 9 lines from powerhouse roof.




Four Peaks started ladder counts on 3/1/23 and will be performing year-round counts for 2023 (Day video 11/1/23 - 2/29/24)
