# **Unit Outages**

Line 1, MU1,2 OOS 10/26/2020 - 2/28/21 for T1 replacement; 1/28/2021 T10 (MU19 & 20) FOOS through 10/28/2021 due to acetylene levels

M8 OOS through 11/15/20 overhaul

#### Maintenance

PUD intake rake out of service due to power track damage. Exploring repair options. Raking with mobile crane as needed.

Five of 6 east fishway collection channel dewatering pumps removed for repair/rehab. Work to resume FY21.

East fishway automation PLC panels installed. All sensor brackets installed. Programming underway. Completion target mid Jan.

Spillway assessment (MRER); Spillgate 9 trunnion pin included.

Calibration checks on fishway entrances and exits 11/10/20, all within criteria.

#### **Predators**

Refer to avian graph tab for bird numbers.

Green laser use for piscivorous bird hazing testing continues. Effective tool for roosting birds during low light.

Cormorants foraging forebay near east ladder exit and entrance. Several herons foraging east fishladder. Three hours observation, one dip, no catch. Invasive aquatic weeds significant at count station pickets and north exit.

Pikeminnow dam angling concluded w/980 removed. All invasive bass/walleye by-catch release continues per states gamefish requirements.

### Research/Construction/Contractors

AWS intake trashrack will continue to be investigated to address the debris plugging issue. Portland district will follow up.

PITAGS north and east fishladder data collection at count stations continues.

Fish unit rehab - Phase 1A. Planning operation with AWS backup water supply during construction. On hold.

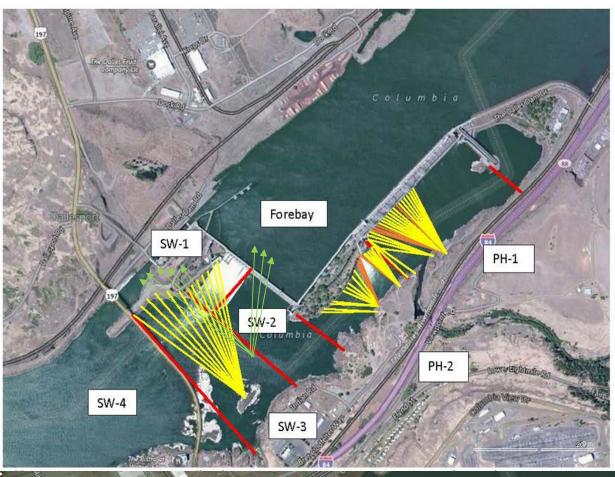
Plans underway it incorporate ODFW sturgeon tagging during upcoming fish ladder dewaterings


North and east fish ladders in full operation.




