Spillgate 14 forced out of service due to operational issues. RTS after spill season. Nine of 15 gates south of spillwall now OOS.

Maintenance

East fishladder wier 155 hoist failed. Weir in down position. Return to service Jan 2023, depending on funding. Forebay restriction 157.

Permanent oil boom reinstall planned for April was postponed until this winter.

Calibrations on east fishway entrances. E-2 ~6" out of calibration, All in criteria.

Spillway assessment (MRER); Spillgates 1- 9 rehab date estimate 2034. Includes replacement of spillbay 9 trunnion pin repair. Spillway crane first priority

Fish unit rehab Phase 1A awaiting funding.

AWS intake trashrack debris management - funded restart FY22.

Gate JP2 hanging down into the top of the east transportation channel about 3~5' at high tail water. Does not appear to delay fish.

Fish units shutdown overnight to flush intake screens of debris 6/23.

Predators

Falconry continues for pushing gulls from count zones. Continuing to track changes.

USDA shore hazing daily. Boating curtailed due to high water and low gull numbers. Falconers daily operations focused on no boat days.

Planning removal of bass/walleye/catfish from all dewaterings for gut sample analysis. Working on permit. Fish Passage Plan 2022 approved.

Large numbers of pelicans present targeting fallback shad and parasitising cormorants. Also appear to be targeting sockeye in culdesac area.

Flows reducing and turbidity decreasing to more normal conditions for avian predators. Gull numbers climbing again.

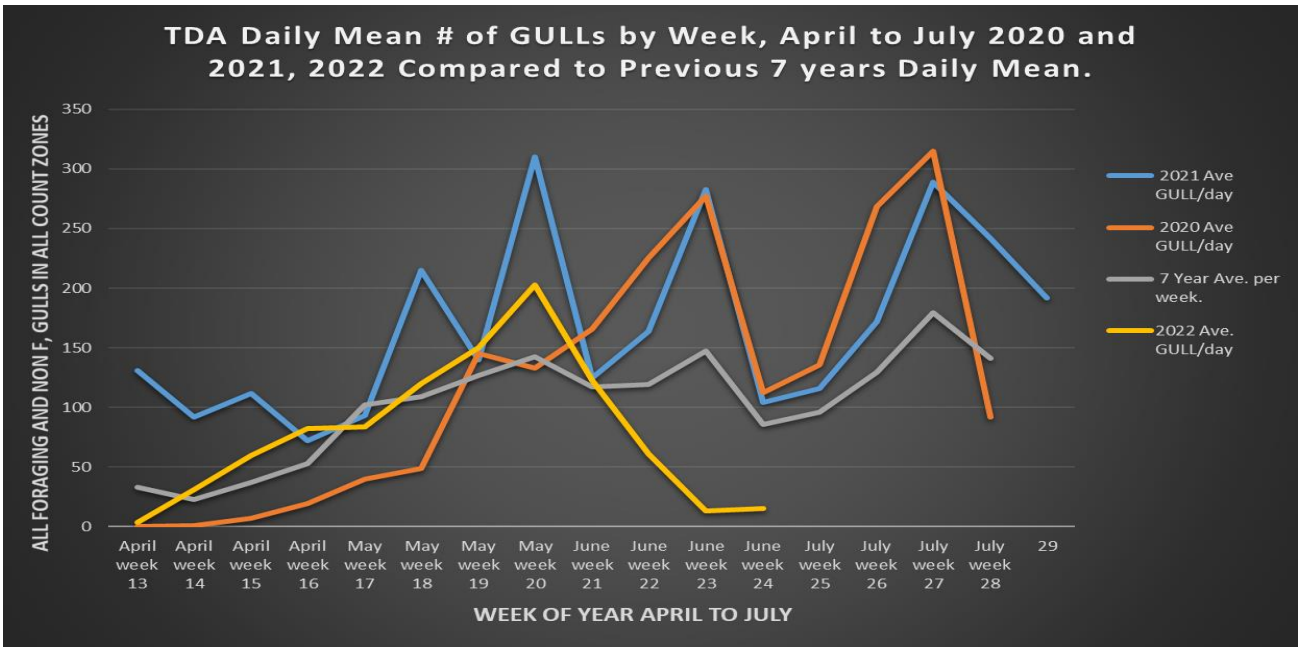
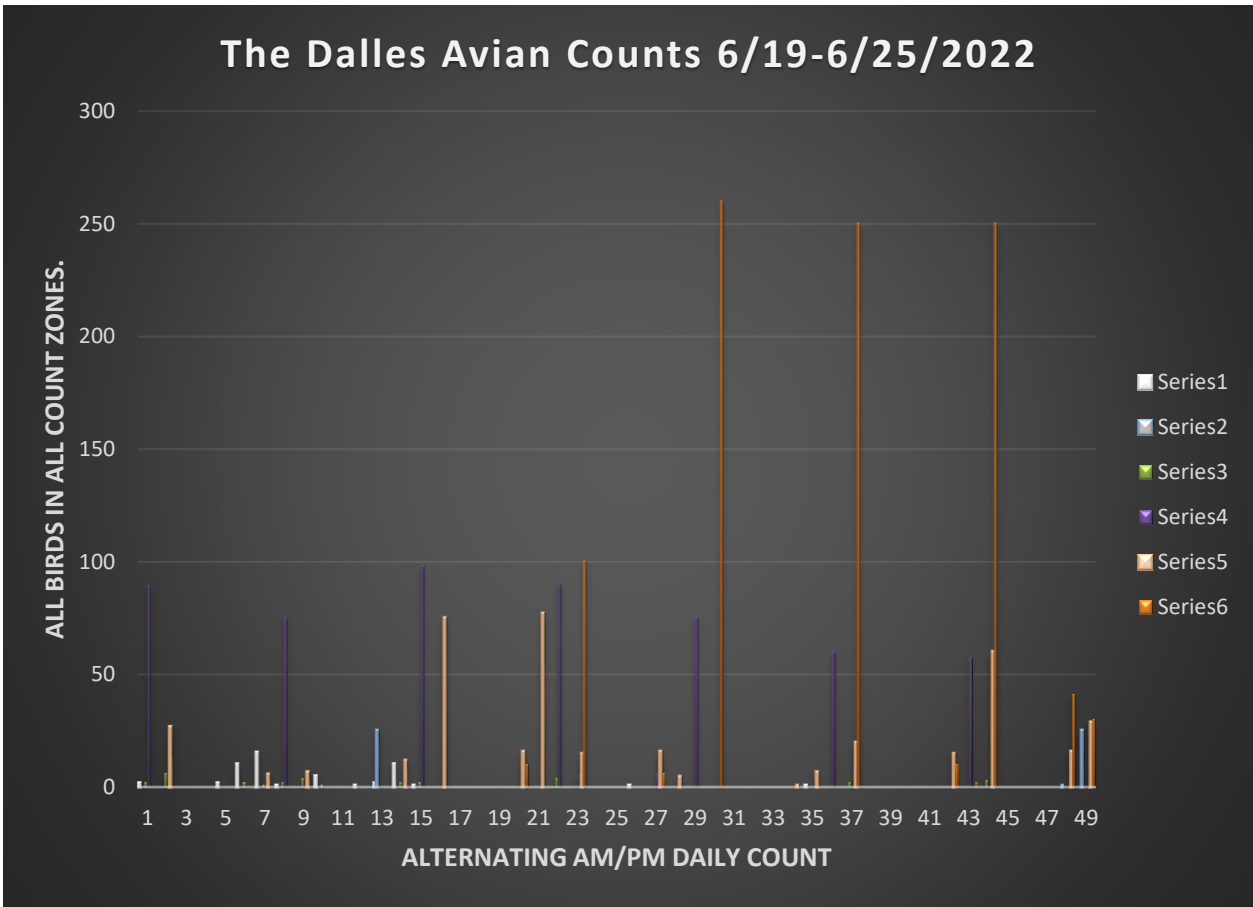
Bird Count Zones, Avian Lines and Laser Deterrent Sites

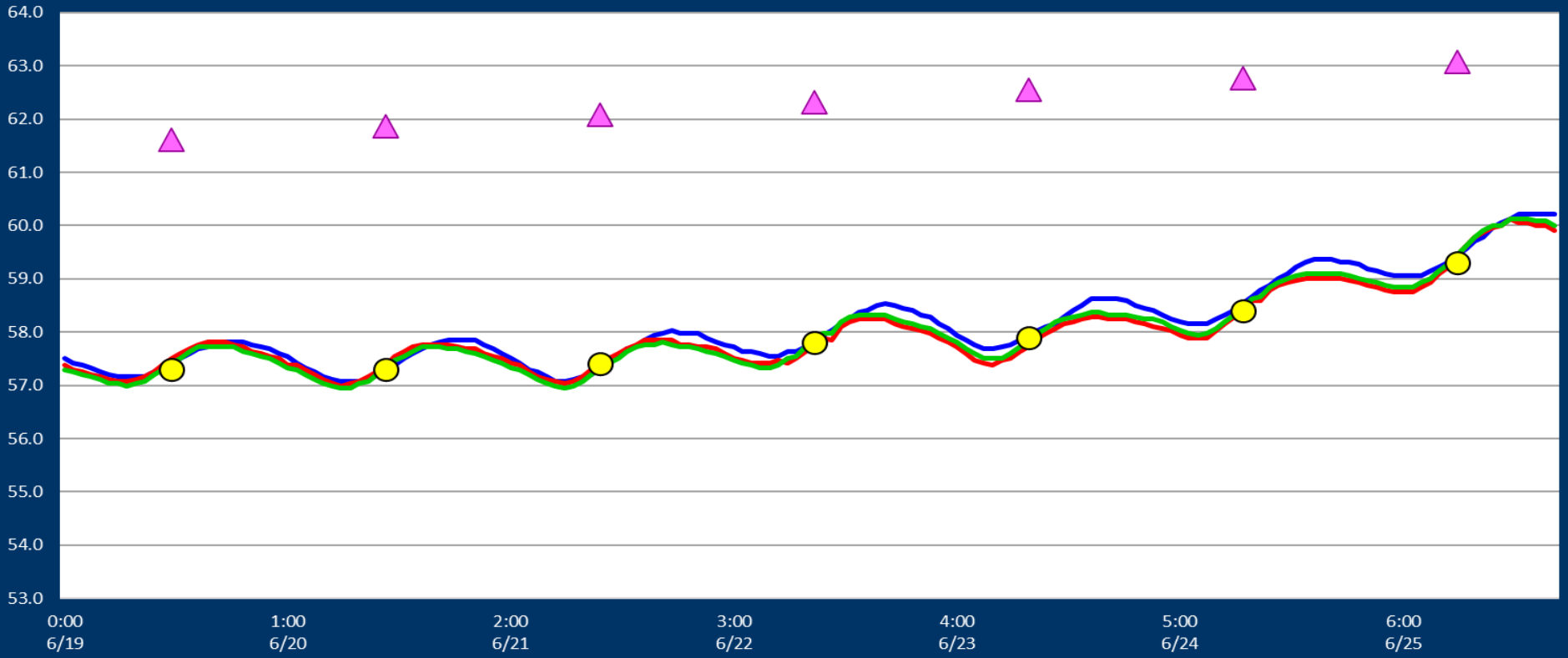
