3. Updates

3.1. North Santiam

Pierce – Screen cleaning scheduled for Tuesday September 6th. Looking at installing a check valve on the air compressor which should help with the leaks. Fire damage contract: should start erecting the storage building on the 8/31, not confidant that they will completed soon, as most of the subcontractors have quit.

- **3.1.1.** Marion Forks Hatchery Grenbemer, Completed marking last week.
- **3.1.2.** Minto Fish Facility Grenbemer, Collection has slowed, 6,850 fish collected to date, 944 non marked collected of which 120 have been held for brood. We are not in criteria with the AWS but not likely delaying migration. We are looking to start spawning next Wednesday. So far have outplanted a total of 3,400 fish with at least 40 more to go. The Breitenbush River has no passage issues and no mortalities have been seen at any outplant sites.
 - **3.1.2.1.** Maintenance activities needed or recently completed. Pierce, Valve replacement on main compressor.

3.2. South Santiam

3.2.1. South Santiam Hatchery – Grenbemer, Collection has slowed, sorting will occur next week, currently release sites are low and clear.

3.2.2. Foster Fish Facility

3.2.2.1. Maintenance activities needed or recently completed.

Pierce, Electricians have resolved most issues. Minor issues are being corrected. Hoist has been inspected and the report should be in next week.

Wertheimer, a key is needed to the minor release site. Walker is working with the BLM to secure a key.

3.2.3. River Bend Adult Release Site, No update

3.3. McKenzie

3.3.1. McKenzie Hatchery – Grenbemer, spawning operations should be starting in two weeks.

Grenbemer, McKenzie fish held at Minto did have higher PSM than North Santiam fish due to additional handling. However, with treatment, mortalities have dropped from the initial rate and should hold till spawning.

Helms, Still have a few fish coming into the facility each day, collected 80 so far this year, 50% recycle rate 58 fish outplanted. Did have a 320mm Sockeye at the facility.

3.4. Middle Fork

- **3.4.1.** Willamette Hatchery Peck, marking is complete, and fish are rearing well. PSM has been lower this year compared to last year. Only 180 fish at the hatchery and only lost two this year. Spawning will begin in about a week.
- **3.4.2.** Dexter Fish Facility Peck, everything is going well, no new fish have come in the last couple weeks. At this time there are only a few fish left in the trap. The road has been closed by the Forest Service to the upper middle fork due to fires, permission has recently been granted to outplant.

Helms, 111 non marked fish outplanted so far, things are slowing now.

- **3.4.3.1.** Maintenance activities needed or recently completed. Pierce minor maintenance going on now, G-DACS is being updated so that the Detroit Dam Operator can monitor the facility remotely.

Wertheimer – Numbers are picking up, fall Chinook are being preyed upon, the 20- animal trigger has not been hit yet but likely will be soon.

- **4.5.** Leaburg Counts (EWEB/USACE) Sachs, 1459 NOR fish have been passed upstream of the dam, only 29 marked fish. Ziller, PHOS is much lower this year than in previous years due to sorter operations and changes in the fish ladder operations. This is the first year that PHOS has been below the target establish in the WV BiOp in 2008.
- **4.6.** Reducing pHOS in the McKenzie River Leaburg sorter Ziller, The sorter has been shut down as of August 29th and we are trapping and sorting fish in the Left Bank Ladder Trap probably through the end of September.
