3.1 [Jan 24] ACTION: Walker – Provide a request for needed changes to the Fish Operations Plan. Changes Due by Feb 15th. Will discuss at the March WFPOM meeting.

Garletts - Will forward for Fall Creek.

Mullan – Will change orders for injunction measures be able to be reviewed?

Walker – Yes, they can be reviewed and will be discussed at the March meeting.

4. Completed Action Items

4.1 [Aug 23] COMPLETE: Sachs/Piaskowski – FY 24 funding is available for genetic pedigree analysis. Contract is expected to be awarded next summer.

Mullan – Can Kathleen O'malley present results in a WFPOM meeting?

Walker – Will look into having O'malley present.

4.2 [Oct 23] COMPLETE: Sachs/Rerecich – 2026 availability of the new Dexter Fish Ladder. The new fish ladder should be available for use in 2026. The expanded collection window in 2024 and 2025 has been verbally agreed to with the Construction Contractor.

5.1. North Santiam

5.1.1. Marion Forks Hatchery – No update, ODFW is at the annual fish production meeting.

- **5.1.1.1.** Marion Creek intake. Wertheimer Ryan McCormick provided a report on the intake with a range of options. We will submit the FY26 execution plan in February and include at least funding for reinforcing the existing structure.
- **5.1.2.** Minto Fish Facility Pierce Bi-weekly maintenance meetings will begin again next week.
 - **5.1.2.1.** Maintenance activities needed or recently completed.
- **5.2.** South Santiam
 - **5.2.1.** South Santiam Hatchery No update.
 - **5.2.2.** Foster Fish Facility Pierce Facility will be out of service for annual maintenance from 30 Jan to mid Feb.

Mullan – When do steelhead start returning?

Sachs – The earliest steelhead in 2023 were collected in April.

- **5.2.2.1.** Maintenance activities needed or recently completed. Annual maintenance period starting in January.
- **5.2.3.** Green Peter Dam outplanting/spawning surveys Draft spawning survey report is being worked on by EAS. Will be presented at the Willamette Science Review. Walker Working on the contracts for both outplanting and spawning survey's and expect to award soon.

Mullan – What is the date of the WSR?

Walker – Have not seen an email for it yet.

5.3. McKenzie

- **5.3.1.** McKenzie Hatchery Sachs Has any further contact or update from EWEB been given on the Cogswell Creek erosion? Sachs will contact EWEB.
- **5.3.2.** Leaburg Hatchery Wertheimer Setting up a meeting with contracting and real estate about the abatement pond pipe.
- **5.3.3.** Cougar Fish Facility Helms Preparing to open the facility on March 15th.

5.4. Middle Fork

5.4.1. Willamette Hatchery – No update.

Mullan – What is the status of RM&E fish for brood year 2023 given the low adult return and juvenile shortfall?

Sachs – Only the minimum number of fish contracted will be provided for RM&E. It will be a significant reduction in numbers, but some fish will still be available for RM&E.

- **5.4.2.** Dexter Fish Facility Pierce Bulkhead will be placed on Feb 6th and contractors will begin work at that time.
 - **5.4.2.1.** Maintenance activities needed or recently completed.
 - **5.4.2.2.** Dexter Fish Facility Header Pipe Sachs USACE is determining if the pipe will be replaced as part of the rebuild or as a separate contract.
- **5.4.3.** Fall Creek Fish Facility Garletts Closed for the winter, planning on opening in mid-March. Hoping to have a in-ladder lamprey trap installed this season. High water this winter may help flush out wildfire debris and improve spawning conditions.
 - **5.4.3.1.** Maintenance activities needed or recently completed.

5.5. Bull trout and Oregon Chub (Taylor)

- **5.6.** WFFDWG/Research updates (Laird) Feb 6th WFFDWG is cancelled as PDT's do not have significant updates. Research to evaluate the injunction measures on the Willamette Basin is ongoing and the RM&E team has been updated.

5.8. Flow update -

Stewart – Beginning refill on 1 February. Currently at 28% above rule-curve with water stored for flood risk management. The mainstem Willamette is close to bankfull and we do not expect to be able to move down to rule curve by the time we start refill.

Cataldi – The Foster nighttime Spring spill injunction measure is scheduled to start on February 1 and will go through June 15. This is the same spring spill operation that has been occurring at Foster for the last several years. An active tag study will be conducted to evaluate the nighttime spill operation, as has been in previous years.

Mullan – How was access with the ice storm?

Cataldi - We are working on establishing communications with Cougar dam. The ice storms did make it difficult to reach projects.

Thompson – Will Green Peter be where it needs to be for spring operations?

Taylor – We are a rain driven system in the Willamette, if we don't get consistent flow, we will not reach target elevations. It's still too early to know if we will meet target elevations. NRCS has products you can use to help predict how the water year will be. We will make the

first prediction around the beginning of April.

7. Willamette Valley Production Contracts

7.1. Willamette Hatcheries – Walker – Contract OY3 will be awarded by Feb 28th and also working a SATOC, this could make it easier to issue task orders then try to mod contracts. Wertheimer – In the Willamette Contract OY3, we are not funding the 172,000 Chinook or 155,300 Summer Steelhead options.

Wertheimer/Sachs – 40k BY2022 Chinook were transferred to RM&E from Production due to escapement from Dexter. By2022 will still make production goal minimums, BY2023 Chinook have about a 30% shortfall.

7.2. Trout Production – Wertheimer – The base of 97,568 pounds of trout has been awarded. <u>No</u> additional funding is available at this time.
